Fireboat 50 Update

On June 24-26, staff traveled to Metal Shark Boats in Lafayette, LA to conduct the 75% construction completion inspection. Staff confirmed construction to date was in compliance with the contract specifications. Staff completed electronics and fire suppression layout. The Fireboat is scheduled for completion in August with delivery in September.



Hurricane Preparedness Town Hall

On June 15th, Staff conducted a Hurricane Preparedness Town Hall in the Community Room. Approximately 20 people were in attendance. Staff made a presentation reviewing hurricane preparedness, during the storm actions and recovery. Fire Chief Byrne, Community Affairs Director Dan Smith and Police Captain Dave Ennis participated.

Police Fire Youth Academy

The Police Fire Youth Academy occurred from June 3-7. Twelve (12) students learned about the duties and responsibilities of Firefighters and Police Officers. The students learned how to use a fire extinguisher, CPR, smoke drill, police & fire rescue marine operations and crime investigations.



Public Education/Community Outreach

- The Department conducted two (2) CPR / AED Classes during June instructing 13 students.
- Firefighters participated in the Little Pink Houses of Hope event on June 5th
- Staff participated in the Collier County Sheriff's Office line of duty death funeral service on June 28th
