(7) NEW BUSINESS

[ID 24-3943](#) Marco Island Seawall Challenges (Member Sokol)

Member Sokol will address the "Marco Island Seawall Challenges" agenda topic on January 16, 2025, which will include discussions on seawall permitting issues.

The Committee summarized agenda topics for the next meeting scheduled on January 16, 2025. The Committee discussed the essential role of barges in seawall work, emphasizing their necessity for transporting materials and equipment. They discussed the importance of ensuring community clarity and acceptance regarding the use of barges. There was also a discussion about the 951 Collier County access point and derelict vessels.

(8) STAFF COMMUNICATIONS**[ID 24-4007](#) ATON Repairs**

The Committee aims to review the areas of the waterway that fall under the city's maintenance responsibility. They have agreed to compile a list of Aton locations in need of repair and to track these repairs using a color-coded system.

Justin Martin, Director of Public Works, provided an update on Aton repairs, including the installation of new signs and replacement of a navigational light. Director Martin remarked on the ongoing efforts to address shoaling issues, discussing the challenges encountered with Collier County.

(10) PUBLIC COMMENT

David Crain, a Marco Island resident, discussed water quality measurements in the local canals and compared the challenges to those observed in the Islamorada canals. He suggested that deep well injection could be a potential solution to improve water quality in the dead-end canals. The discussion also covered wastewater treatment and geological conditions in Florida.

Justin Martin, Director of Public Works, provided insights on the water supply and infrastructure on Marco Island. He also covered topics related to water management and the use of injection wells.

Nick Pierson raised concerns about the closure of the 951 loading area and construction costs.
