Subject: Public Works Departmental Report – May 2025

The City's public works department has 13 dedicated employees that administer, repair, and maintain the city's public infrastructure including traffic signals, streetlights, roads, sidewalks, swales, street signs, stop signs, median landscaping and irrigation, city street trees, storm sewer drainage, and bridges.

The following summarizes the department's operations over the month of April:

Public Works Capital Projects Overview:

N. Collier Blvd./N. Barfield Dr. intersection

- Contractor executing contract and procuring bonds.
- Project will commence upon receiving executed contract and required bonds.
- Construction Schedule: June 2025 June 2026

Canal Aeration Pilot

- The installation of the aerator is estimated to be completed in mid-June.
- Following the installation of the aerators, ten weeks of sampling and testing will be conducted, covering parameters such as dissolved oxygen (DO), temperature, conductivity, oxidation-reduction potential (ORP), depth, and airflow.
- Construction and Pilot Study Schedule: June 2025 Sept. 2025

Traffic Signal Control Replacements

- The design kickoff meeting took place on May 16, focusing on replacing traffic signal controllers and the importance of standard details and schematics.
- Design: May 2025 Nov 2025
- Bidding: Nov 2025 Jan 2026
- Construction: Feb 2026 Aug 2026

Pedestrian Safety Improvements

- The design kickoff meeting took place on May 16, covering pedestrian safety upgrades and the implementation of blank-out signals.
- Design: May 2025 Oct 2025
- Bidding: Nov 2025 Jan 2026
- Construction: Feb 2026 Aug 2026

Tidal Flushing/Canal Interconnects

- Bids rejected 2024
- Awaiting additional grant funding. The city's grant consultant is assisting.

San Marco Drainage Improvements Project:

The San Marco Drainage project is nearing completion, with approximately 97% of the work finalized. A substantial completion letter has been issued.

The remaining tasks include minor punch list items and final documentation. The project is progressing as scheduled and is expected to be fully complete in the coming weeks.



Collier Blvd. Irrigation

The city's irrigation sprinklers on Collier Blvd. from Winterberry Dr. to the Jolley bridge spray reclaimed water to irrigate the landscaping. Runoff of reclaimed water into the storm drainage systems is prohibited by the Florida Administrative Code . A Marco Island water quality activist group reported irrigation runoff onto the pavement to FDEP which then cited the city for a violation. City staff directed the city's landscape contractor to inspect and make repairs to all sprinkler heads to minimize runoff onto the pavement. However, given the water pressure of the reclaimed irrigation and the limited width of the landscaped areas, spray onto the pavement cannot be avoided.



The city has been irrigating the roadsides in addition to the medians since Collier Blvd was reconstructed in the early 2000's. All roadside landscaping and sod everywhere else in Marco Island is irrigated by the adjacent properties. Most single-family homes that have irrigation irrigate the area between the pavement and sidewalk with their respective irrigation sprinkler systems.

The city will discontinue irrigating the roadsides (from the curb to the property lines) on Collier Blvd. to be consistent with all other areas in Marco Island whereby property owners irrigate up

to the pavement. Also, to mitigate the reclaimed water spray onto the pavement from the medians, the city will replace sprinkler spray heads with bubbler type heads to soak the landscaped ground rather than spraying into the air. In FY 26 the city will remove the dead sod in the medians and replace with mulch which does not require spray type irrigation. These changes are necessary to comply with regulations for the land application of reclaimed water to avoid violations.



Advisory Committee Support

In addition to the above projects, PW staff attends and supports the Waterways Advisory Committee, the Beautification Advisory Committee, and the Hideaway Beach Tax District Board, and the bike lane and shared path strategy group including the preparation of meeting minutes, conducting research, updating the city website related to committee functions, coordinating among committee members, and attending additional meetings, and responding to requests.

Water Quality Action Items

The following table lists the water quality action items being considered or performed by the city. The items appearing in gray text are not recommended, not feasible, and not implemented.

Collier Blvd. from Huron Ct. to the end of Collier Ct. is being publicly bid. Bids open on May 27. More exfiltration swale project designs are on the way in FY25. The right of way construction standards manual was revised to require that exfiltration swales be constructed as part of the right of way permitting process. Thus far over 15 residential right of way permits include the construction of exfiltration swales.
