Employee News



The Marco Island Police Department received a safety incentive reimbursement designed to offset the cost of new ballistic vests. This equipment provides critical life-saving protection for our police officers. The ability to purchase and replace them on a regular schedule, defined by the manufacturer, is invaluable to the officer, City and the community they serve.

Community Oriented Policing

In July, the Marco Island Police Department had some special visitors from Camp Mackle. Campers got a behind-the-scenes look at what we do and had a blast exploring our police vehicles, sirens included! We always enjoy welcoming the next generation and showing them how we serve and protect our community.



July Police Activity Crime Report:

In July 2025, 62 incidents were reported to the Marco Island Police Department. Total crimes against persons increased by 50% (6 vs. 4) compared to the same time last year due to a slight increase in domestic battery offenses. Property crimes increased (11 vs. 6) compared to last year due to incidents of burglaries. Miscellaneous crimes decreased by 46%. In July 2025, crimes against society, such as DUIs decreased compared to last year. The Marco Island Police Department had 3 arrests in July 2025 for instances of Domestic Battery and for an Out of County Warrant.



2025. vs 2024 Incident Trend


In July 2025, there were 36 non-criminal incidents reported. 28% of non-criminal incident reports were comprised of suspicious incidents. 19% of reports referred to assistance to other agencies including Collier EMS, Marco Island Fire Department, and other law enforcement agencies. 28% of non-criminal incident reports are for lost and found property. The Marco Island Police Department will accept found property into our property and evidence department for safekeeping until an owner can be located. 19% of reports were due to domestic disturbances.



This data highlights the diverse range of non-criminal incidents that the department responds to, emphasizing both public safety and community support. Compared to June of last year, there was a rise in non-criminal incident reports due to more reports regarding assisting EMS or other agencies.

Traffic Patrol

In July 2025, the Marco Island Police Department issued a total of 96 traffic citations and warnings. Of the written citations, 28% were for failure to obey traffic signs or traffic lights, 48% were for operating a motor vehicle with an expired registration or driver's license, and 14% were issued for other violations such as equipment issues. Additionally, officers seized eight driver's licenses due to license suspension or revocation. The department's traffic enforcement strategies are guided by citizen complaints, identified problem areas, and analysis of crash data to ensure targeted and effective enforcement efforts throughout the community.



Detective Bureau Monthly Investigative Report

Detective Bureau data reflects the number of cases assigned to the bureau each month. These totals do not account for active investigations carried over from previous months and, therefore, do not reflect the bureau's overall caseload.

• The Detective Bureau handled a 31% decrease (13 vs 19) in Battery/Assault cases in 2025 compared to the same period in 2024. There has been 21% decrease (55 vs 70) in Suspicious Incident cases. Theft cases are up 3% (31 vs 30) when compared to the same period last year.

July Marine Report

The Marine Report reflects activities conducted by MIPD Marine Officers while patrolling Marco Island's waterways and canals. These activities include proactive patrols to enforce marine and environmental regulations and promote boater safety.

In July, Marine Patrol experienced a slight increase in activity compared to the previous month, with a total of 442 events, up from 405 in June, an approximate 9.1% increase in activity. The July 4th holiday was safely managed, despite rough seas and the presence of waterspouts throughout the day. These conditions significantly limited boater activity, contributing to a quiet and incident-free holiday on the water. We also experienced our typical July afternoon weather, with frequent heavy storms that periodically kept personnel off the water for safety.


July 2025 Beach Patrol:

July 2025 Code Enforcement Officer (CEO) Report:







Code Officers' activity in July 2025 remained predominantly self-initiated, with self-initiated investigations exceeding dispatched cases (604 vs.45). Summer rains have resulted in weeds and tall grass violations having the highest number of violations for July. Lawn maintenance often needs to be done more frequently in the summer months to avoid code violations. ROW obstruction violations are down 18% from last month. The high volume of self-initiated investigations underscores the proactive efforts of Code Officers in identifying and addressing issues before they escalate or are formally reported.

^{**} There were 29 cases scheduled for the Special Magistrate Hearing in the month of July. 4 cases were for Landscape Certificate violations. 16 cases were for the Certification of Fines, which involves placing a lien for unpaid fines. There were 2 cases for Mitigation of Fines on the July Docket. Mitigation is a structured process to evaluate reducing the financial penalty associated with a violation or offense.

Special Duty Details refer to law enforcement duties performed for an outside vendor in addition to an officer's regularly scheduled work hours. These voluntary assignments include, but are not limited to, traffic and security at various locations. Off-season Special Duty hours are lower as expected, compared to other times of the year with the Farmers Market. July Special Duty hours exceeded Junes by 67. Special Duty assignments in July consisted of patrol and property surveillance hours for a private business.
