SUBJECT: First Reading of Ordinance Revising Code of Ordinances

On May 6, 2024, the Council held a workshop to discuss the progress draft of the code update. The draft provided for the workshop was approximately 95 percent complete. Changes made to complete the draft after the workshop are highlighted in yellow (and were included in the advance copy provided to Councilors in late June).

As of the date of this memorandum, comments from one Councilor and the Fire Marshall were received. The comments that are summarized below are incorporated into the ordinance for first reading:
