Fire Rescue Training

The Fire Rescue Department dedicates the summer months to fire rescue and advanced life support training. During the month of July, Firefighters participated in countywide highrise training at a donated multi-story building in the City of Naples. The training was attended by all County Fire Departments. This valuable highrise training opportunity resulted in improvements to highrise firefighting equipment and hose deployments. The training was instructed by the Training Officers from the five county fire departments. Firefighters also attended compressed natural gas (CNG) training provided by a CNG supplier. Firefighters seeking to test for Driver Engineer participated in evolutions to complete their Position Task Book.

Fourth of July

Fire Rescue staff conducted numerous activities on July 4th for the fireworks display. Fire Inspectors conducted several inspections of the fireworks barge during rack set-up and loading of the explosives. Once anchored at the shoot site, the fireworks are wired for the display. Fire Inspectors were transported by Fireboat 50 to conduct a final inspection and approved the shoot. Firefighter Paramedics staffed the Departments beach rescue vehicle responding to medical emergencies occurring on the beach. Following the fireworks show, the vendor contacted the Fire Marshal to confirm all shells were shot. The Fire Marshal provided the approval for the barge to return to port.



Colonel Glenn Waters

Colonel Glenn Waters spent one of his days with the Fire Rescue Department. He met with staff to discuss fire operations, fire prevention and training. He also toured the equipment and experienced the Fireboat operation. He also attended a Hurricane Planning Cell meeting and received an overview of the City's Emergency Management Operation.

- The Department conducted two (2) CPR / AED Classes during June instructing eight (8) students.
- Firefighters participated in the Middle School Summer Nights event on July 5th
- Staff provided CPR/AED instruction to two (2) MIPD Officers

- Marco Island Academy walk thru safety inspection was conducted on July 24th
