NOTICE OF PUBLIC HEARING

The City of Marco Island Planning Board/Local Planning Agency proposes to consider the following ordinance:

AN ORDINANCE OF THE CITY OF MARCO ISLAND, FLORIDA, AMENDING THE OFFICIAL ZONING ATLAS OF THE CITY OF MARCO ISLAND, TO PROVIDE FOR THE REZONING OF THE PROPERTY LOCATED AT 560 S. COLLIER BLVD., MARCO ISLAND, FLORIDA, CONSISTING OF APPROXIMATELY 10.44 ACRES FROM "RESIDENTIAL TOURIST (RT) ZONING" TO "PLANNED UNIT DEVELOPMENT (PUD) ZONING"; AS CONTAINED IN APPLICATION NUMBER REZ-24-00009; MAKING SPECIFIC FINDINGS; PROVIDING THAT APPROVAL DOES NOT CREATE A VESTED RIGHT; PROVIDING FOR FAILURE TO COMPLY WITH THIS ORDINANCE; PROVIDING FOR INTERPRETATION, AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

A public hearing on the proposed ordinance will be held by the City's Planning Board on Friday, July 31, 2026, in the Community Room, Marco Island City Hall, 51 Bald Eagle Drive, Marco Island, Florida, 34145 at 9:00 a.m., or as soon thereafter as may be convenient to the Planning Board/Local Planning Agency. The public hearing may be continued from time to time.

A copy of the application associated with this rezoning is available for public review in the office of the Growth Management Department, Marco Island City Hall, 50 Bald Eagle Drive, Marco Island, Florida, 34145, Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m., excepting city holidays. With respect to the request, interested parties may appear and be heard at the public hearing, or may submit written comments at the hearing or prior to the hearing to Daniel J. Smith, Community Affairs Director at DSmith@cityofmarcoisland.com, 50 Bald Eagle Drive, Marco Island, FL 34145, (239)-389-9000. The public is hereby advised that members of the City Council may be present at the meeting and may discuss the request and proposed Petition.

Pursuant to Section 286.0105, Florida Statutes, the City hereby advises you that if you or another person decide to appeal any decision made by the Planning Board/Local Planning Agency with respect to any matter considered at its meeting or hearing, that you or said person will need a record of the proceedings, and that for such purpose, affected persons may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. This notice does not constitute consent by the City for the introduction or admission into evidence of otherwise inadmissible or irrelevant evidence, nor does it authorize challenges or appeals not otherwise allowed by law.
