Subject:	Public Works Departmental Report – July & August 2024

The City's public works department has 13 dedicated employees that administer, repair, and maintain the city's public infrastructure including traffic signals, streetlights, roads, sidewalks, swales, street signs, stop signs, median landscaping and irrigation, city street trees, storm sewer drainage, and bridges.

The following summarizes the department's notable activities over the month of April:

#### Barfield Dr. Drainage

Construction of drainage improvements including adding drainage pipes and inlets in the swales is in progress. These drainage improvements will help to alleviate flooding in the area. Construction is expected to be completed in March of 2025.

## **Annual Street Resurfacing**

Paving has been completed on portions of S. Collier Blvd. between San Marco Rd. and Winterberry Dr. Paving on S. Barfield Dr. is in progress and will be completed after the drainage piping in the area is installed. Paving on Buttercup Ct. has been completed. Waikiki Ct. and Fairlawn Ct. are being paved now. Paving on 6<sup>th</sup> Ave. is next.

The paving on S. Barfield Dr. is being done as an overlay without milling to raise the elevation of the road since it is too low and chronically floods. A flood remediation project for S. Barfield Dr. is slated for design and construction in FY25.

#### **N. Barfield Shared Path**

The shared path on N. Barfield Dr. has been constructed between Collier Blvd. and Laurel Ct. Construction is progressing from Laurel Ct. towards Bald Eagle Dr. The shared path consists of a new 8ft. wide concrete sidewalk. Concerns of affected homeowners are being addressed in a timely manner. This project is slated to be completed by the end of FY24.

## **Traffic Signal Posts and Mast Arm Painting**

The contractor completed the painting of the posts and arms at the San Marco Rd./Collier Blvd. intersection. Painting of the San Marco Rd./Cushing Ln. and the San Marco Rd./Barfield Dr. intersections are next.

## **Advisory Committee Support**

In addition to the above projects, PW staff attends and supports the Waterways Advisory Committee, the Beautification Advisory Committee, and the Hideaway Beach Tax District Committee, and the Bike Lane and Shared Path Ad-Hoc Committee including the preparation of meeting minutes, conducting research, updating the city website related to committee functions, coordinating among committee members, and attending additional meetings, and responding to requests.

#### Water Quality Action Items

The following table lists the water quality action items being considered or performed by the city. The items appearing in gray text are not recommended, not feasible, and not implemented.
