*City of Marco Island Public Works Director Justin Martin outlined the recent history of the City's water nutrient source evaluation and remediation efforts for the Council's background and perspective. He reminded the Council of its direction upon initially reviewing the unsolicited public private partnership "P3" proposal from Earthwerks Land Development Corp. and ENCAP, Inc., and he introduced representatives from the Humiston & Moore Engineers Review Team** to present their assessment of the "P3" proposal.*

Attorney Debbie Madden led the presentation of the Review Team's findings to the Council, aligning the structure of its findings in accordance with the provisions outlined in Sec. 255.065 (3)(c) of the Florida Statutes.

Attorney Zach Lombardo, Woodward, Pires & Lombardo, P.A., representing the Proposer (Earthwerks Land Development Corp. and ENCAP, Inc.), outlined the Proposer's interest in: 1) addressing the questions raised by the Humiston & Moore Engineers Review Team; 2) assuming the responsibility and cost for developing a project design solution to address the City's canal sediment issues, and; 3) obtaining all required Federal and State approvals and permits before requesting the City of Marco Island's commitment to engage in the proposed public private partnership.

Mr. Dan Davies, representing Earthwerks Land Development Corp. and ENCAP, Inc., reiterated the statements advanced by Attorney Lombardo and, together with Attorney Lombardo, addressed a number of questions from members of the Council.

Interim City Manager Casey Lucius provided additional perspective regarding the City's performance responsibilities for any permits and/or grants issued in connection with this proposed public private partnership.

City of Marco Island Finance Director Carol McDermott outlined the statutory requirement that this Resolution be publicly announced prior to January 1, 2026, and she highlighted the key elements of non-ad valorem (vs. ad valorem) assessments.

17. Council Communications & Future Agenda

Councilor Henry complimented the Christmas Island Style Committee and all who participated in the annual Marco Island Christmas Tree Lighting Ceremony on December 6th.

Councilor Henry reminded the Island's residents and guests of the annual Christmas parade on San Marco Road on Saturday, December 12th.

Councilor Henry concluded her remarks by wishing her colleague Councilors and all members of the community a wonderful Holiday Season.

Councilor Brechnitz expressed his concern with Governor Desantis's proposal to eliminate property taxes on homesteaded properties in the State of Florida. He requested that the City Staff engage its legislative consultant, Mr. Ron Book, in identifying alternatives that the Florida State Legislature might be discussing to allow for alternative revenue sources for Florida municipalities that are highly dependent upon property tax revenue to sustain their operations.

Vice-Chair Champagne advised the Council of his recent conversations with the City's Interim City Manager regarding annual fiscal year-end financial reviews with the City Council. He expressed his displeasure with the year-end FY2025 financials not being on the Agenda for the Council's December 8th meeting, and he requested that an annual City balance sheet review be included in this and all future year-end reviews.

Interim City Manager Casey Lucius and City Finance Director Carol McDermott indicated that the year-end FY 2025 financials were reviewed with the City of Marco Island Audit Advisory Committee at its December 4, 2025 meeting, and that the year-end FY 2025 financial results will be provided to the Council well before the Council's January 5, 2026 meeting.

Vice-Chair Champagne reminded that Council that the City's external auditing firm, CliftonLarsonAllen (CLA), expressed its expectation that the City's FY2025 financial audit would likely identify some "citations" and improvement recommendations for the Council and the City's Staff's action when its report is issued in the spring of 2026.

City Finance Director McDermott indicated that she and her staff are already preparing documentation for CLA's initiation of the FY2025 audit, and that she and Ms. Chris Kessler of CLA are already collaborating on a process of communications and in-process audit reviews with her and the Audit Advisory Committee.

Councilor Goehler thanked the City Staff, her colleague Councilors, and members of the public for working together for the good of Marco Island, and she wished all a wonderful Holiday Season.

Councilor Gray asked for clarification as to whether the Council appropriately approved the Consent Agenda earlier in the meeting. City Clerk Joan Taylor confirmed that a vote by the Council on the amended Consent Agenda was undertaken as required.

Councilor Gray noted a proposed amendment to the Florida Clean Air Act coming before the Florida Legislature during its upcoming annual legislative season. Given its potential effect on the use of smoking and vaping products on Florida beaches, he indicated his intention to await the results of that legislation before raising this issue for the Council's future consideration.

Later, during Councilor Communications, Councilor Gray indicated his belief that the City should consider alternatives on the Island to facilitate the staging of material by private marine seawall contractors.

Councilor Schwan briefly reviewed the provisions of Section 7 (Conduct of Meetings) in the City of Marco Island City Council Rules of Procedure relative to the ability of recognized speakers being allowed to speak without interruption.

Councilor Schwan also highlighted the Marco Island City Council Rules of Decorum regarding "...slandering, disparaging or unduly repetitive remarks ...", and she requested that Chair Palumbo and the Council enforce this provision with members of the public who violate this rule. Several Councilors provided their perspective on this issue.

Chair Palumbo indicated his intention to act upon both of Councilor Schwan's requests.

Chair Palumbo solicited the Council's thoughts on an emailed request for action by the Oceana organization regarding the Federal Bureau of Ocean Energy Management's (BOEM's) 11th National Outer Continental Shelf Oil and Gas Leasing Program public comment opportunity. The Councilors indicated their intention to provide individual comments as appropriate. City Clerk Joan Taylor was asked to distribute a copy of the email to each Councilor.

Chair Palumbo assured the Council that he will continue to move the Council's proceedings along in a manner that balances the Council's need to make decisions and effectively utilize its time together.

Chair Palumbo outlined the nature of his recent conversations with Collier County District Commissioner Rick LoCastro regarding the staging of material by Collier County and private marine contractors near the north end of the Judge SS Jolley Bridge.

Chair Palumbo reported on the results of his discussion with Florida District 81 Representative Yvette Benarroch regarding her proposed legislation to address impasses in the appointment of City Councilors who carry out the remainder of an elected Councilor's term of office. He noted that he views this matter as now "closed" and will be brought before the electorate for its consideration.

Chair Palumbo noted the Marco Island Academy's 5X Matching Endowment Campaign, and he offered his endorsement of community action and support of this Campaign.

Chair Palumbo recognized and thanked Councilor Henry for her commitment to fulfill the Christmas wishes of all of the homeless children's Christmas gift wants that were displayed on a local business "Giving Tree". He expressed his appreciation for the generosity of all of his colleague Councilors with whom is serving in office, and extended Holiday wishes to all of them.

Legislative Consultant Ron Book has been scheduled to address the City Council on the status of the Florida Legislative Session on state property tax reform and other issues of interest to the City of Marco Island during a February meeting of the City Council.

18. Council Reports

Councilor Schwan reported that the Collier County Metropolitan Planning Organization (MPO) is finalizing its selection of a new Executive Director and that an appointment to that position is expected to be announced in January.

19. Citizens' Comments

Dr. Rich Blonna (San Marco Rd.) expressed concern with the City potentially spending millions of dollars in the application of Advanced Water Treatment technology for the City's reuse water utility without providing commensurate public access to the City's canal system for those who do not reside in properties along the City's canals. He encouraged the Council to consider installing non-motorized watercraft public access docks at Veterans Community Park, Castaways Park, and Caxambas Park.
