

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, APPROVING A BOAT DOCK EXTENSION REQUEST SUBMITTED BY THE BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA ("TIITF"), FOR A BOAT DOCKING FACILITY THAT EXTENDS ONE HUNDRED-SIXTY-SIX FEET (166') FROM THE SUBJECT PROPERTY LINE FOR THE PROPERTY LOCATED AT 2561 SAN MARCO ROAD, MARCO ISLAND; MAKING FINDINGS OF APPROVAL; PROVIDING FOR FAILURE TO OBTAIN OTHER DEVELOPMENT PERMITS; PROVIDING FOR FAILURE TO COMPLY WITH APPROVAL; AND PROVIDING AN EFFECTIVE DATE.**
