b. [ID 25-4630](#) Amendment of Articles of Incorporation - Article 7.11 Financial Disclosure

*Chair Brechnitz briefly outlined the conditions that were in effect when the Articles of Incorporation for the Foundation were ratified, and he invited Director comment on whether Article 7.11 of the Foundation's Articles of Incorporation should be amended to eliminate the filing of a Florida Financial Disclosure Statement by prospective Directors.*

*No members of the public came forward to offer comment.*

**MOTION by Director Cox, seconded by Director Richards, that Article 7.11 of the Marco Island Community Parks Foundation Articles of Incorporation be amended to eliminate the requirement that Directors file the same Florida Financial Disclosure Statement (i.e. Form 1) required of municipal officers, be Approved. *Chair Brechnitz confirmed the status of the Foundation's agreement to date with its primary donor family, and he advised Director Siegel, as Chair of the Marco Island Parks & Recreation Advisory Committee (PRAC), that any new PRAC proposals for application of the donor funds can be brought forward to the Foundation Board for its consideration.*

*Director Richards initiated a discussion with the Directors on the Foundation's structure, mission, and efficiency in organizing activities, raising funds, and improving the infrastructure and operation of the City parks, particularly at the Marco Island Racquet Center.*

*City Manager Mike McNees, Community Affairs Director Daniel Smith, and Parks, Culture & Recreation Manager Samantha Malloy all provided insight for the Foundation Board's consideration.*

**d. [ID 25-4632](#) Discussion - Recommendation for Racquet Center Improvements - Mr. Tim Annett, Guest Speaker**

*Attorney Zach Lombardo of Woodward, Pires & Lombardo, P.A., as representative of Marco Island Racquet Center member Tim Annett and other pickleball players who utilize that facility, shared his client's interest in leading a fundraising activity to improve that facility, provided that: 1) the Foundation would be willing to be the custodian for donated funds under the proposed fundraising effort, and; 2) that certain understandings and agreements with the Foundation and the City of Marco Island could be accommodated.*

*Attorney Lombardo volunteered, on behalf of his clients, to undertake additional research to better estimate the capital, additional operating expenses, and financial break-even calculation associated with the execution and ongoing maintenance of improved/expanded pickleball facilities at the Marco Island Racquet Center.*

*Attorney Lombardo also volunteered to bring the results of his client's research to the Marco Island City Council for review and endorsement to proceed before returning to the Foundation Board to discuss its potential role as custodian for any future fundraising amounts on behalf of his clients.*

*Chair Brechnitz raised, for the Foundation Board's consideration, the potential benefit of hiring a professional fundraising resource to assist the Board in establishing an endowment to fund future capital projects and to generate an on-going source of income to maintain existing Foundation assets.*

*The Board briefly discussed the merits of professional fundraising efforts relative to recent examples of fundraising success by energized interest groups, with an expectation of continued discussion at a future meeting of the Foundation Board.*

*Secretary Joan Taylor reminded the Board of its requirement to meet monthly as noted under Article 7.3 of its Articles of Incorporation, and the Directors confirmed a third Wednesday of the month meeting schedule with a starting time of 1:30 P.M. for its future meetings.*

*Director Dolores Siegel noted that an existing vacancy exists on the Foundation Board.*

*Chair Brechnitz confirmed the desire of the current Directors to continue to serve in their current capacity on the Board. He advised the Directors that a Resolution approving their re-appointment would be forthcoming to the Marco Island City Council for approval.*
