# **Status of Fire Apparatus**

The mechanical issues of the fleet are described as follows:

# Ladder Truck

• On June 20<sup>th</sup> February 18<sup>th</sup>, the Departments Ladder Truck returned from the Service Center and was placed in-service. The extensive repairs totaled \$92,108.06 which was approved by City Council on March 3, 2025. The Ladder Truck was out of service for 122 days.

#### City of Marco Island Hurricane Preparedness Town Hall

City staff presented the 2025 Hurricane Preparedness Town Hall on June 18<sup>th</sup>. The Town Hall experienced excellent turnout from our residents. Trisha Dorn from LCEC and State Representative Yvett Benarroch also served as presenters.

#### **Contract Negotiations**

On June 25<sup>th</sup>, the first collective bargaining session was conducted with the Professional Firefighters of Marco Island. The existing 4-year contract expires September 30, 2025. The session consisted of negotiating team introductions, approval of ground rules and the temporary approval of 11 Contract Articles. The next session is scheduled for July 17<sup>th</sup>. The City's Negotiation Team consists of Assistant City Manager Casey Lucius, Fire Chief Chris Byrne and Deputy Chief Matt Marshall.

#### Project Update

#### High Water Fire Engine

Staff attended the prebuild conference on June 19<sup>th</sup> completing and approving the specifications. Delivery is expected in March 2026. This project includes \$212,000 in Legislative Appropriation funding which was successfully reappropriated in the State 2025-26 budget.



# CAMMI

On June 20<sup>th</sup>, members of the Condominium Association Managers of Marco Island attended a lunch & learn at Fire Station 50 with the Fire Marshal and Fire Inspectors. The topics discussed included hurricane preparedness, maintenance of fire protection systems and new legislation item affecting condominium associations.

# Public Education/Community Outreach

- The Department conducted one (1) CPR / AED Classes, instructing five (5) students.
- Staff conducted the Police / Fire youth Academy the week of June 2 6. Eight (8) middle school students participated.
- Firefighters conducted the annual safety walkthrough of Marco Island Academy with school staff on June 3<sup>rd</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 20<sup>th</sup>, 23<sup>rd</sup>.
- Fireboat 50 conducted a safety standby for the Great Dock Canoe Race on June 14<sup>th</sup>
- Fireboat 50 participated in the City of Naples Police / Fire Youth Academy on June 19<sup>th</sup>.

Of the 179 responses, 147 incidents are medical emergencies accounting for 48% of the incidents for the month, The remaining 32 incidents in the 300 category include lift assists, vehicle accidents, watercraft rescues, and elevator rescues.

# **Notable Highlights & Activities**

#### 1. Fire Investigation – 506 Bradford Court

On June 23, 2025, during an active storm, the Marco Island Fire Rescue Department responded to a residential attic fire at 506 Bradford Court. The fire was traced to the area where a Corrugated Stainless-Steel Tubing (CSST) gas line (TracPipe) penetrated the attic. While CSST is commonly used for fuel gas distribution, it is susceptible to lightning-induced electrical arcing, especially when not properly bonded.

In this case, nearby lightning activity likely induced an electrical charge on the unbonded CSST system, resulting in arcing, gas leakage, and ignition at the entry point. The fire was brought under control by Marco Island Fire Rescue with auto-aid support from the Greater Naples Fire District during overhaul operations. The fire was ruled accidental by the Fire Marshal, with the cause identified as lightning-induced arcing on unbonded CSST. No injuries were reported.

#### 2. Training – Post Blast Investigations

Fire Marshal Zunzunegui completed 40 hours of advanced training at the State Fire College on Post Blast Investigations.

#### 3. Public Education – Sal E Pepe

On June 12, the Fire Prevention Division conducted commercial kitchen fire-safety and fire extinguisher training for 30 staff members at Sal E Pepe. The session focused on kitchen suppression systems, emergency response procedures, and included hands-on use of portable extinguishers to reinforce best practices in workplace fire safety.

#### 4. Code Conformance Support

Fire Prevention personnel conducted or participated in six technical coordination meetings with contractors and design professionals. These sessions provided early-phase guidance and support for construction and renovation projects to ensure fire and life safety code compliance.
