





Marco Island Local Bill: City of Marco Island, COPCN (Collier County): by Representative Rommel and approved by Governor – Chapter No. 2018-184 (HB 1395).

In 2018, the City asked us to develop legislation that would allow for a referendum regarding direct ambulance response and service. (Procedurally, the City needed a specific type of legislation called a local bill which would apply only to an area less than the total area or population of the state – only the City. In order to accomplish this, legislation must pass, be approved by the Governor, and then the City must hold a referendum. The local bill process requirements are specified in section 10 of Article III of the State Constitution.)

We worked with the City, delegation members and House and Senate leadership to move this bill forward through the committee and floor process, to ultimately work with the Governor for his approval. The referendum was on the August 2018 ballot, but failed with a vote of 53% to 46%, due to the expected cost to residents for this service.

The legislation would have authorized the Department of Health to issue the City a license to provide basic and advanced life support services, without the city obtaining a COPCN (Certificate of Public Convenience and Necessity) directly from Collier County, provided the City meets all the customary requirements for a COPCN license, in s. 401.25(2)(a), (b), and (c), F.S. The DOH then may issue a license to the City to enable the city's Fire Rescue Department to provide prehospital or interfacility advanced life support services or basic life support transportation services.

Explain how the firm approaches the legislative cycle to advance the City's legislative program.

We abide by three key principles when organizing and managing lobbying activities and projects for the City, and use these as guiding principles in our ongoing representation regarding the prioritization of issues important to the City of Marco Island.

- During the Legislative committee weeks and Session, provide reports weekly or more frequently as issues arise, regarding appropriations and legislation, provide a final report after the end of the session, including the funding request final outcomes and the outcome of the City's priorities.




