This proposal consists of professional services required for Environmental and Engineering Professional Services for the 2026 maintenance along Tigertail lagoon and Sand Dollar Island Spit. The proposed maintenance aims at addressing steep escarpments along the spit shoreline. This will be accomplished by excavation of 7, 000 to 9000 cubic yards of sand from the stand trap and placing the sand seaward of the escarpments to achieve the required grads prior to nesting season. This will address compliance requirements for the Tigertail Lagoon/Sand Dollar Island Ecosystem Restoration Project.
