Facilities Update:

Mackle Park

• The lake has been sprayed for vegetation growth. The algae bloom that is present now is a typical reaction to the stronger herbicide treatment (Sonar) that was applied on May 8th and May 15th to treat the overgrowth of Hydrilla vegetation. The bloom is normal, and it may be a bit of a larger bloom than expected due to the higher temperatures we've had and lack of rain. We should

start seeing a noticeable improvement in the conditions of the lake over the next 2-3 weeks. An increase in rainfall would also help to expedite the improvements. The Hydrilla is beginning to decrease not only from the stronger herbicide treatment, but from the stocking of carp. The City stocked the lake with fifty Triploid Grass Carp on April 5th. The stocking of the carp along with the stronger herbicide treatment should manage the aquatic vegetation for up to a year and half or more.

- A new coil for the AC has been ordered and will be in in about three weeks.
- FWC has been contacted regarding the Burrowing Owl burrow on our athletic field. No owls have been spotted. We are waiting for approval for relocation of the burrow.

- The scoreboard and remote are installed.




Planning Board:

Water Quality

• Staff received the May 2019 quarterly water quality reports from the Collier County Pollution Control Lab for testing done on the Marco Island Waterways. The total nitrogen counts exceeded the FDEP standards at 11 of the 12 sites. The FDEP threshold for nitrogen is .30 mg/L. Below are the results for each sampling location.

Iguanas

• The Iguana Trapper continues to work on the Island once a week. For the month of May, he trapped and removed over 60 Iguanas. Currently, there is \$8,500 left in the budget for these services, which should run through September.

Mackle Park Lake

• Since the stocking of fifty of Triploid Grass Carp on, April 5th, there appears to be a reduction in the overgrowth of Hydrilla vegetation in Mackle Park Lake. To further address the vegetation overgrowth, the City purchased a stronger herbicide treatment called Sonar which was applied on May 8th & May 15th. In conjunction with the carp, the stronger herbicide treatment should be effective in treating the vegetation overgrowth. There is an algae bloom present that is a reaction to the application of the Sonar treatment. The algae bloom is being treated also and conditions should improve over the next few weeks. Staff and the City's lake management will continue to monitor the conditions.
