# 9. Citizens' Comments on Items Not Scheduled for Public Hearing and Items Other Than Those Appearing on the Agenda

Mr. Tom Gunkel (Coronado Ct.) followed up on his request during Citizens' Comments at the Council's June 2, 2025 meeting to reiterate his difficulties in obtaining permission to have his boat removed from the water for service at Caxambas Park. Mr. John Martini (Nassau Ct.) identified maintenance conditions primarily at Mackle Park, and secondarily at Veterans Community Park, which he believed should be addressed to better maintain those park's amenities and provide more effective shade coverage for park visitors.

City Attorney Alan Gabriel provided the Council with a verbal report on two out-of-compliance Code cases (City of Marco Island v. Artesian Pool Construction, Inc., and City of Marco Island v. JRL Underground Utilities Proposal

City of Marco Island Public Works Director Justin Martin outlined this project's relationship to the City's actions under its Category 4e plan with the Florida Department of Environmental Protection (FDEP), and he highlighted the funding sources which will be contributing to this project's completion.

**b.** <u>ID 25-4497</u> Use of Body-Worn Cameras in the Police Department - Discussion, Chief Tracy Frazzano

Marco Island Police Chief Tracy Frazzano, and Police Lieutenant Joe Belardo, presented the results of their research into the costs, benefits, and considerations in implementing the use of body-worn cameras for the sworn officers of the Marco Island Police Department.

**Public Comment** 

Ms. Anita Sargese (Manor Terr.) offered her perspective and knowledge of lower-cost alternative providers and applications that she observed at one law enforcement department in New Jersey.

Following considerable discussion, the Council elected to follow Police Chief Frazzano and Lieutenant Belardo's recommendation to not direct the City Staff to pursue a body-worn camera implementation plan for the Marco Island Police Department at this time.

# 16. Items Removed from the Consent Agenda

No items were removed from the Consent Agenda at this meeting.

### 17. Council Communications & Future Agenda

Vice-Chair Gray complimented the efforts of current and former members of the Beach & Coastal Resources Advisory Committee and the City's Code Enforcement Department for working together to identify and eradicate noxious and invasive species of plants on Marco Island.

Vice-Chair Gray also requested that an item be added to the Council's Future Agenda (see next page).

Councilor Schwan requested Council consensus to direct the City Staff to draft a Proclamation expressing Council support for the continued operation, by Collier County, of regional airports near Everglades City, Immokalee, and Marco Island. [Editorial Note: Council consensus was obtained and the Proclamation was added to the Council's Future Agenda]

Councilor Schwan requested that the City Staff collect and issue a report on the type, number, and the amount of fines assessed by the City over the past five (5) years, along with: 1) how much has been collected, and; 2) what liens have been placed on properties over the corresponding period.

Councilor Schwan acknowledged the concerns raised during Citizens' Comments regarding: 1) allowable activities at Caxambas Park, and; 2) the need for additional shade at Mackle Park. Councilor Schwan noted that the City Manager is actively engaged with Collier County leadership on the Caxambas Park concern, and that the Council is considering additional shade structures in its 2026 Fiscal Year budget.

Councilor Henry acknowledged and thanked members of the City's Beautification Advisory Committee for assisting and providing recommendations to property owners along Mainsail Drive who are interested in beautifying their roadway medians.

Councilor Henry also thanked members of the Calusa Garden Club for the floral arrangements that they provided for: 1) the recent Little Pink Houses of Hope sailing on the Marco Princess, and; 2) the Noontime Rotary Club Spirit Awards Event on April 26, 2025.

Chair Brechnitz queried Marco Island Police Chief Tracy Frazzano on the recent animal control issue found on Marco Island, and he shared his insights on the history of the ownership of that property.

Councilor Palumbo expressed his agreement and support for the comments offered by Vice-Chair Gray and Chair Brechnitz, while also expressing caution with attempting to create special allowable activity "carve outs" at Caxambas Park. He shared a proposed marina use management plan document for

Caxambas Park, and various members of the Council shared their perspectives on elements of it.

City Manager McNees reiterated and confirmed Councilor Schwan's earlier observation regarding his effort to reach a satisfactory solution for Caxambas Park with the leadership of Collier County.
