1 A bill to be entitled
2 An act relating to the City of Marco Island, Collier
3 County; amending City of Marco Island Charter, created
4 by chapter 97-367, Laws of Florida, and as amended by
5 local ordinance to require a special election be held
6 to fill any vacancy on the city council; providing an
7 exception for vacancies occurring within 1 year of a
8 general election; providing for the Governor to fill
9 vacancies under certain circumstances; providing for a
10 referendum; providing effective dates.

12 Be It Enacted by the Legislature of the State of Florida:

14 **Section 1. Subsection (3) of section 3.05 of Article III**
15 **of City of Marco Island Charter, created by chapter 97-367, Laws**
16 **of Florida and as amended by City of Marco Island Ordinance No.**
17 **02-20 and City of Marco Island Ordinance No. 09-15, is amended**
18 **to read:**

19 (3) (a) A vacancy on the Council shall be filled by holding
20 a special election for the unexpired term to be called by the
21 city clerk upon a resolution adopted by the council. Said
22 election shall be held within sixty (60) days of the vacancy,
23 unless such vacancy occurs within one (1) year of a general
24 election of city officials, in which event the Council shall,
25 within sixty (60) days following the occurrence of such vacancy,

26 by a majority vote appoint a citizen qualified under section
27 5.03 of the Charter who shall hold office until the next general
28 election.

30 ~~(a) If a vacancy occurs and the remainder of the unexpired~~
31 ~~term is 28 months or less, the remaining Council Members shall,~~
32 ~~within sixty (60) days following the occurrence of such vacancy,~~
33 ~~by majority vote of the Council Members, appoint a person to~~
34 ~~fill the vacancy for the remainder of the unexpired term.~~

35 ~~(b) If the remainder of the unexpired term exceeds 28~~
36 ~~months, the remaining Council Members shall, within sixty (60)~~
37 ~~days following the occurrence of such vacancy, by majority vote~~
38 ~~of the Council Members, appoint a person to fill the vacancy~~
39 ~~until the next regularly scheduled City election at which the~~

42 (b)(e) If four or more Council vacancies occur at one time
43 or the Council does not appoint a qualified citizen to fill a
44 vacancy within sixty (60) days, the Governor shall fill such
45 vacancies until successors are chosen at the next regular
46 election.

47 **Section 2. Referendum -**

48 (1) The referendum election called for by this act shall be
49 held on November 3, 2026, concurrent with the 2026 general
50 election.

52 in substantially the following form:

55 (3) The referendum question shall be placed on the ballot
56 in substantially the following form:

57 Shall Chapter 2026- , Laws of Florida, amending the
58 charter of the City of Marco Island to provide for a special
59 election to be held within sixty (60) days of any Council
60 vacancy, unless the vacancy occurs within one (1) year of a
61 general election, in which event the Council shall appoint a
62 qualified citizen to hold office until the next general
63 election, and providing for appointment by the Governor of
64 certain vacancies, become effective?

67 **Section 3.** This act shall take effect only upon its
68 approval by a majority vote of qualified electors residing in
69 the City of Marco Island voting in a referendum held on November
70 3, 2026, except that section 2 and this section shall take
71 effect upon becoming a law.
