JOB DESCRIPTION

Contractor shall furnish all labor, materials, equipment, and incidentals necessary to complete the Winterberry Beach boardwalk replacement project. Work includes mobilization, site setup, and maintenance of safe access and staging areas throughout construction.

Scope includes demolition and disposal of the existing boardwalk, installation of new timber pile foundations driven to bearing, and construction of a new boardwalk system within the existing footprint. Structural work consists of cap beam and stringer framing utilizing rough sawn treated lumber, along with installation of composite decking and all required marine grade hardware and fasteners.

Work also includes construction of an ADA accessible switchback ramp, refurbishment and reinstallation of existing handrails, and coordination of permitting, engineering, and survey as required. Contractor shall perform all necessary cleanup and demobilization upon completion.
