Any alterations or deviation from the previously stated specifications involving extra costs will be an additional charge over and above the amount of this contract.

ALL PLANTS ARE GUARANTEED FOR A PERIOD OF SIX (6) MONTH WITH OUR MAINTENANCE PROGRAM. That includes Lawn Care and Pest Control of Lawn and Ornamental (Any alterations from above specifications involving extra costs will be executed only with written orders, and will become an extra charge over and above the estimate. Contractors furnished materials remain the property of Affordable Landscaping until payment terms are met. Owner gives Affordable Landscaping permission to repossess all material without notice, or recourse, at the owner's expense. All agreements contingent upon strikes, accidents, acts of God, vandalism, damage from other contractors and delays beyond our control.)

This proposal is subject to acceptance within 30 days and is void thereafter, at the option of Affordable Landscaping. Overdue accounts are subject to 1.5% per month service charge (18% Annual Interest Rate). Purchaser agrees to pay all costs of collection, including reasonable attorney's fees and costs without regard to whether or not litigation shall have been commenced, should collection proceedings be required.
