**AN ORDINANCE OF THE CITY OF MARCO ISLAND, FLORIDA; AMENDING CHAPTER 50, "TRAFFIC AND VEHICLES," SECTION 50-37, "PROHIBITED PARKING," BY PROHIBITING PARKING IN CITY SWALES, NORTH OF OLD MARCO LANE, THAT DO NOT HAVE LEGALLY PERMITTED IMPROVED PARKING; PROVIDING FOR SEVERABILITY/INTERPRETATION; AND PROVIDING AN EFFECTIVE DATE.**

The public hearing may be continued from time to time.

With respect to the request, interested parties may appear and be heard at the public hearing, or may submit written comments at the hearing or prior to the hearing to Daniel J. The public is hereby advised that members of the City Council may be present at the meeting and may discuss the request and proposed Petition.

Pursuant to Section 286.0105, Florida Statutes, the City hereby advises you that if you or another person decide to appeal any decision made by the Planning Board/Local Planning Agency with respect to any matter considered at its meeting or hearing, that you or said person will need a record of the proceedings, and that for such purpose, affected persons may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. This notice does not constitute consent by the City for the introduction or admission into evidence of otherwise inadmissible or irrelevant evidence, nor does it authorize challenges or appeals not otherwise allowed by law.
