State of Florida Emergency Medical Services (EMS)

On November 7th, a representative from the State of Florida EMS Office completed an Advanced Life Support compliance inspection. The Department successfully passed the inspection. This is the final step of the licensing process. Now, as a state licensed agency the City is eligible for the annual State Emergency Medical Services Grants, 75/25 funding for equipment, training etc. On November 29th, the Department submitted an EMS Grant application requesting funding in the amount of \$13,500 to acquire Video Laryngoscopes. The equipment was requested in the City FY26 budget but was not funded.

Promotion

On December 10th, Training Captain Jake Clemons was promoted to the rank of Division Chief. In this role, Division Chief Clemons will lead the Division of EMS & Training. Division Chief Clemons played a critical role in the Department's successful attainment of the COPCN and Advanced Life Support state licensing. He will manage the Departments EMS Operations.

Hurricane Season

The 2025 Atlantic Hurricane Season ended on November 30th. This season is the first hurricane season in 10-years (2015) without a Gulf or US Hurricane landfall. This was a welcome break for City staff and our residents.

Phoenix Awards

On December 2nd, six (6) Firefighter Paramedics received the Phoenix Award. The Award honors individuals and teams who have successfully resuscitated a victim of cardiac arrest. The following personnel received the award:

Accomplishment

On December 12th, Fire Inspector Louis DeMoya successfully completed and graduated from the Fire Academy earning his state certification as a Firefighter. Louis attended the Academy at night and on weekends to not interfere in his responsibilities as a Fire Inspector.

Records Management System

The United State Fire Administration launched the new interoperable fire information and analytics platform known as the National Emergency Response Information System (NERIS). The Fire Rescue Department's records management program went live on the NERIS platform on January 1, 2026.

Fire Apparatus

Tower 50: Was removed from service on November 21, 2025, due to a hydraulic leak. The Ladder Truck was out of service for 38 days to accomplish repairs. The truck was placed back in service on December 29th. The cost of the repair was \$23,297.61.

Regional Incident Management Team

Chief Byrne and Deputy Chief Marshall participated in the Regional Incident Management Team Working Group session on December 2nd. The Working Group consists of members of the Florida Forest Service and Fire Chiefs from Lee, Collier and Charlotte Counties. The group plans and coordinates the response to large brush fire incidents which impact the region.

Public Education/Community Outreach

- During November and December, the Department conducted five (5) CPR / AED Classes, instructing sixty-two (62) students.
- The Department distributed fifteen (15) NARCAN administration kits during the month of December.
- Firefighters conducted a safety standby during the Chilli Cookoff event on November 1st.
- Firefighters participated in the Veterans Day Ceremony on November 11th.
- Firefighters participated in the Marco Lake Dr. Christmas event on December 18th in partnership with Al's Pals and the Police Department.
- Staff attended the City Council meeting on November 3rd as Captain Paramedic Munier Gattas was recognized for his 20 years of service to the City.
- Firefighters participated in a Bike Rodeo on November 5th at the Marco Island Charter Middle School.
- Firefighters participated in the Meals of Hope meal packaging event on November 8th.
- Firefighters participated in the Patty Bake Humane Society Naples 2026 Calendar photo shoot.
- Firefighters participated in numerous Christmas Island Style events during the holiday season.

Fire Prevention Division – Monthly Report | Reporting Periods: Nov & Dec 2025

Executive Summary

During November and December 2025, the Fire Prevention Division continued to support safe development, regulatory compliance, and community risk reduction through plan review, inspections, enforcement, investigations, and professional collaboration.

In November 2025, the Division generated \$40,719.16 in revenue, bringing the FY25–26 year-to-date total to \$111,446.57, exceeding the prior fiscal year's comparable period. Activity levels remained consistent with ongoing construction and redevelopment trends, with 387 permit inspections and 124 fire plans reviewed. Enforcement activity declined compared to the previous year, reflecting improved compliance and proactive coordination with building managers, contractors, and design professionals.

In December 2025, the Division generated \$36,027.60 in revenue, increasing the FY25–26 year-to-date total to \$147,474.17. Fire plan reviews increased to 137 for the month, while inspection volumes remained steady. Re-inspection and violation activity continued to trend downward year-over-year, indicating effective early intervention and code guidance.

Two fire investigations were conducted during the reporting period, including a recurrent concealed-space residential fire and a marine vessel fire involving an onboard generator. Fire Prevention staff also provided code conformance support through multiple coordination meetings and hosted a regional dry floodproofing training to support resilience and emergency preparedness.

Overall, the Fire Prevention Division maintained strong operational performance while supporting development, enforcement consistency, interagency collaboration, and professional training in alignment with the Department's mission of Community, Honor, and Tradition. **As the calendar year closed, the Division generated \$859,425.46 in total 2025 revenue and completed 2,087 fire plan reviews and 4,603 new construction/permited inspections, reflecting sustained service demand and continued support to the City's development activity.**

Notable Highlights & Activities for November & December of 2025

Fire Investigations

- Residential Garage Fire – November 22, 2025: At approximately 1942 hours, fire units responded to a report of smoke in the attached garage of a single-story, single-family residence. Investigation identified the origin as a concealed header/wall cavity near the garage door motor/controller; corresponding to a prior fire at the same location on February 27, 2025. Fire suppression and overhaul were completed, followed by origin-and-cause evaluations on November 22, 24, and 25 with assistance from building, fire, and electrical officials and a licensed electrician. No definitive ignition source was identified; intermittent low-voltage readings were noted within the lath-and-plaster wall assembly but were inconclusive. The cause remains undetermined. The homeowner was advised not to re-energize the residence until concealed wiring is exposed, evaluated, and traced back to the panel by a licensed electrician.
- Marine Vessel Fire – November 8, 2025: At approximately 1315 hours, crews responded to a reported fire involving a docked Boston Whaler 350 Realm. Investigation identified the generator compartment as the area of origin. The EFI generator exhibited heat damage and charring concentrated at the electrical harness/control side, with localized heat staining to the surrounding enclosure. No evidence of fuel leakage or vapor ignition was found. The fire was classified as accidental, most consistent with an electrical malfunction or component failure, with damage largely confined to the generator area.

Code Conformance Support

- Fire Prevention staff participated in eleven coordination meetings with contractors and design professionals, providing early guidance to support compliance with fire and life safety codes during the design and construction phases.

Professional Development & Training

- On November 18, 2025, Fire Prevention hosted a Dry Floodproofing training course presented by Flood Risk America. Attendees included local building officials, condominium managers, Collier County Floodplain staff, and Fire Rescue personnel. The course covered code requirements for dry floodproofing systems, active mitigation strategies, emergency planning, applicable federal regulations, and distinctions between optional and required mitigation for enforcement officials. Demonstration props were provided, including active and passive floodproofing systems, as well as a panel system that allowed firefighters to practice forcible entry techniques using chainsaws and specialty tools during simulated storm-event conditions.

Administrative / Professional Activities

Fire Marshal Daniel Zunzunegui participated in Building Official interview panels during the months of November and December.
