Employee News

Community Oriented Policing

June Police Activity Crime Report:

In June 2025, 46 incidents were reported to the Marco Island Police Department. Total crimes against persons decreased by 67% compared to the same time last year. Property crimes remained consistent with data for June of last year. Miscellaneous crimes decreased by 40%. In June 2025, crimes against society, such as DUIs decreased by 67% compared to last year. The Marco Island Police Department had 3 arrests in June 2025 for instances of DUI, disorderly intoxication and fleeing and eluding.


Note: Non-Criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost, and found items and medical assists.

Note: Multiple criminal offenses may have occurred within some incidents. This reporting aligns with new crime data collection requirements from the Florida Department of Law Enforcement and the FBI. This announcement for crime reporting was covered in the February 2022 monthly report. Non-criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost and found items and medical assists.

2025. vs 2024 Incident Trend

In June 2025, there were 62 non-criminal incidents reported. 22% of non-criminal incident reports were comprised of suspicious activities and 5% of reports were referencing assistance to other agencies including Collier EMS, Marco Island Fire Department, and other law enforcement agencies. 22% of non-criminal incident reports are for lost and found property. The Marco Island Police Department will accept found property into our Property and Evidence Department for safekeeping until an owner can be located. 4% of reports were due to domestic disturbances.




This data highlights the diverse range of non-criminal incidents that the department responds to, emphasizing both public safety and community support. Compared to June of last year, there was a rise in non-criminal incident reports due to more reports regarding assisting EMS or other agencies.

Traffic Patrol

In June 2025, there were 70 traffic citations and written warnings issued by the Marco Island Police Department. Of the written citations issued, 28% were for failure to obey traffic signs or traffic lights. 61% of citations were for operating a motor vehicle with an expired registration or driver's license. In June 2025, the Marco Island Police Department made 1 criminal traffic arrests for driving under the influence and seized 3 licenses due to license suspension or revocation.

The Marco Island Police Department uses citizen complaints, known problem areas, and crash data analysis to determine our traffic enforcement strategies.

• The Detective Bureau handled 66% fewer (1 vs 3) Battery/Assault cases in 2025 compared to the same period in 2024. There has been 33% decrease (4 vs 6) in Suspicious Incident cases. Theft cases are down 80% (1 vs 5) when compared to the same period last year. Battery/Assault cases have decreased by 47% (10 vs 19).

June Marine Report

The Marine Report reflects activities conducted by MIPD Marine Officers while patrolling Marco Island's waterways and canals. These activities include proactive patrols to enforce marine and environmental regulations and promote boater safety.

June statistics were in line with January and February of this year. Water activity was impacted this month due to the occurrence of strong afternoon storms and an increase in training activities for new marine and patrol officers.


June 2025 Beach Patrol:




June was a month of education on our beaches. Code Enforcement Officers take time from their beach patrol duties to greet and educate children on beach safety and our unique local wildlife. Code Enforcement Officers also provided education to our visitors about the dangers of open flames on our beaches and the consequences the flames may cause.

June 2025 Code Enforcement Officer (CEO) Report:







Code Officers' activity in June 2025 remained predominantly self-initiated, with self-initiated investigations exceeding dispatched cases by a substantial margin of 619 (924%). A consistent trend continues with trash violations ranking among the most common code enforcement issues; ROW obstruction violations are down 83% and Weeds violations are down 57% from June of 2024. The high volume of self-initiated investigations underscores the proactive efforts of Code Officers in identifying and addressing issues before they escalate or are formally reported.


^{**} There were 26 cases scheduled for the Special Magistrate Hearing in the month of June. 3 cases were for the Certification of Fines, which involves placing a lien for unpaid fines. There were 5 cases for Mitigation of Fines on the June Docket. Mitigation is a structured process to evaluate reducing the financial penalty associated with a violation or offense.

Notably, in June 2025, 8,056 more calls for service were officer-initiated in the field, than being driven by 911 or administrative dispatch. This reflects a continued emphasis on proactive policing.
