**STATE-FUNDED TERMINATION AGREEMENT**

THIS TERMINATION AGREEMENT made and entered into this \_\_\_ day of \_\_\_\_\_, by and between the **STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION** (hereinafter “DEPARTMENT”) and **CITY OF MARCO ISLAND** (hereinafter, “AGENCY”).

**WITNESSETH:**

WHEREAS, the DEPARTMENT and the AGENCY on **May 11<sup>th</sup>, 2023** entered into a State-Funded Grant Agreement (hereinafter, “Agreement”) in connection with **City of Marco Island / Construction and CEI of Marco Island Smokehouse Bay Bridge Replacement (#034113)**; and

WHEREAS, the DEPARTMENT and the AGENCY have mutually agreed to terminate the agreement and services at the present status of completion and in accordance with Section 5 of the Agreement; and

WHEREAS, the DEPARTMENT has reimbursed the AGENCY under the terms of this Agreement the sum of \$ 0.00 leaving a balance of **\$0.00** still due and payable to the AGENCY by the DEPARTMENT.

NOW THEREFORE, in accordance with terms of the executed Agreement, the parties agree as follows:

1. The AGENCY agrees to termination of the Agreement dated **May 11<sup>th</sup>, 2023** with the DEPARTMENT.
2. The AGENCY shall be reimbursed by the DEPARTMENT for all work completed up to and including the effective date of this Termination Agreement.
3. The AGENCY shall not be reimbursed for any work completed after the effective date of this Termination Agreement.
4. The AGENCY shall not be reimbursed for any work completed prior to the effective date of this Termination Agreement that fails to meet with the standards specified by the DEPARTMENT.
5. Upon execution of this Termination Agreement, the DEPARTMENT shall reimburse the AGENCY the sum of **\$0.00**, which the AGENCY agrees to represent the balance due to the AGENCY and is the final payment for services rendered pursuant to the Agreement.
