Re: May 2024 Monthly City Council Report

This May, Marco Island Police Department hosted and participated in a variety of career path and youth engagement events. To kick off the summer, on May 3rd, Marco Island Police Department joined the Marco United Methodist Church along with Al's Pals, Marco Island Charter Middle School, Capri Christian Church, YMCA of Collier County and Marco Fire Rescue at the Middle School Block Party. This event was to celebrate the beginning of summer for hard working middle school students and is a great example of keeping the community connected in a safe and positive environment.

Also on May 3rd, 2024, Marine and Traffic Sergeant Ryan Montgomery and Reserve/ Auxiliary Officer Ray Leshinger joined over 20 different local professionals at Manatee Elementary School for the 5th Graders career day. Students had the chance to ask questions about law enforcement and were provided with a hands-on experience, allowing them to create lasting memories with our officers while giving them an idea of what potential law enforcement career paths may be ahead of them.

On May 21st, 2024, 7th Graders from Marco Island Charter Middle School visited the Marco Island Police Department to observe rescue operations, traffic equipment and patrol vehicles. MIPD's Officers explained their roles and the impact being a law enforcement officer can have in the community.

Community engagement and interaction with the youth is an extremely important facet of Law Enforcement. Encouraging positive interactions with Law Enforcement can lead children to build trust in their community and in the officers who serve it. The MIPD will continue to seek opportunities to connect with members of the community through these events.







May Police Activity Crime report:

In May 2024, 85 incidents were reported to the Marco Island Police Department. Total crimes against persons increased by 50% compared to the same time last year. Property crimes increased in May 2024 by 60% due to a higher incidence of thefts and criminal mischief incidents. Miscellaneous crimes showed an increase of 38% due to a rise in out of county warrants and trespass warnings. In May 2024, there was a 50% decrease in crimes against society due to fewer narcotics incidents. The Marco Island Police Department had 12 arrests in May of 2024 for incidents including domestic violence related simple assault, out of county warrants, driving under the influence, criminal traffic violations, possession of narcotics, and resisting a law enforcement officer with violence.

Note: Multiple criminal offenses may have occurred within some incidents.

This reporting aligns with new crime data collection requirements from the Florida Department of Law Enforcement and the FBI. This announcement for crime reporting was covered in the February 2022 monthly report.

Non-criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost and found items and medical assists.

2023 vs 2024 Incident Crime Trends

In May 2024, there were 41 non-criminal incidents reported. 27% of non-criminal incident reports were comprised of suspicious activities. 10% of non-criminal incident reports were due to domestic disturbances, with no crimes occurring. 8% of reports were referencing assistance to other agencies including Collier EMS, Marco Island Fire Department, and other law enforcement agencies. 22% of non-criminal incident reports are for lost and found property.



May Traffic Patrol

Motor Vehicle Thefts

In May 2024, there were 209 traffic citations and warnings issued by the Marco Island Police Department. Of the citations issued, 28% were for failure to obey traffic signs or traffic lights. 27% were due to an excess in posted speed. 24% of citations were for operating a motor vehicle with an expired registration or driver's license. Other citations issued were for violations including safety belt infractions, improper passing, and illegal U-turns. In May 2024, the Marco Island Police Department seized 9 licenses during traffic stops due to suspensions or revocations. 1 license plate was seized during a traffic stop.

Quarterly Crash Report

The Marco Island Police Department quarterly crash information data is portrayed in the heat map displayed. Areas where crashes are more densely concentrated will appear on the heat map as a "hotter" location, indicated by red or orange color. Crashes that are more severe will also appear "hotter" to reflect a more severe accident occurrence.

On March 1, 2023, the Governor approved Senate Bill 1614, which expanded public records exemptions to Crash Reports and Uniform Traffic Citations. Due to this change, crash report data became exempt from public disclosure for 60 days after the date of the crash occurrence. Q1 crash data was available for review beginning on June 01, 2024.


In Q1 (January – March 2024), 87 crashes were reported within the municipal city limits of Marco Island. This quarter saw a major increase in crashes as compared to Q4 2023 (October - December 2023). This could be correlated with the increase in population on Marco Island during Q1. Of the 87 reported crashes, 86% were non-injury related and 90% were in clear weather conditions. Most accidents were

between 12pm and 4pm, with concentrations on Thursdays. Data showed that most of the accidents involved drivers over the age of 65 and that male drivers were responsible for 71% of accidents. March had the most crashes in Q1. There were 4 alcohol/ impaired driver related crashes in Q1, comprising 4.5% of total crash events.

May Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.

May Marine Report

Marine Officers were scheduled for additional patrol during Mother's Day and Memorial Day weekends due to an expected influx of boaters in the areas surrounding Marco Island. Patrol vessels and PWCs were deployed for both weekends. FWC and CCSO Marine Units partnered with MIPD to ensure a safe weekend for everyone to enjoy. Due to the increased presence of Police Marine Units, the MIPD reports 0 major incidents on the water or beaches. Marine Officers also conducted vessel safety and sanitation inspections of anchored vessels in Smokehouse and Factory bays. All vessels were following Coast Guard regulations.

Marine Officer Bob Marvin Jr retired this month after 37 years in law enforcement. His knowledge and expertise regarding Marine Policing and safety has made him a valued

FWC, Collier County Sheriff's, Naples Fire Rescue, Marco Island Fire Rescue, Rose Marina, and Sea Tow celebrated Officer Marvin's retirement with a unified flotilla. The MIPD FireHouse Subs Rib Boat was officially decaled and fashioned with proper equipment for Marine Patrol. Rib Boat training will be held in June in preparation for its potential use during Hurricane Season. PWCs and Patrol Vessels received maintenance in the month of May and are in proper working order.

Beach Report

In May 2024, Marco Island's beaches saw an increase in beachgoers, resulting in a significant increase in all beach events and activities. Code Enforcement Officers providing information and directions to community members was the most

significant event increase, resulting in 142% more calls for service compared to last month. Additionally, pick up of litter and debris and "No Glass on the Beach" enforcement increased this month, which is extremely important due to active Sea Turtle nesting having begun on Marco Island.




Code Enforcement:



May Special Magistrate Hearing

The Special Magistrate Hearing took place on May 28, 2024. There were 15 cases scheduled to be heard. 15% of the scheduled cases were weed related violations again this month. Silt Fence violations also comprised 15% of the cases on the docket. Damaged Sidewalk cases made up 10 % of the docket, and Special Magistrate Robert Pritt cautioned violators to correct them as quickly as possible within the defined process to avoid injury and potential litigation.

<u>Code Enforcement Protected Species</u>

In May, there were 19 burrowing owl cases. 17 of these involved reported violations of the protection zone, (parking within 33 feet of the owl burrows). Of the 17 cases, 1 NOV was issued, 14 verbal warnings were issued, two were unfounded. There were two cases involving injured owls. One was turned over to Audubon of the Western Everglades, (AWE) one was turned over to FWC. This month there were 3 cases involving Gopher Tortoises. One involved a protection zone violation (parking within 25 feet of a burrow) resulting in the issuance of an NOV. Sadly, one Gopher tortoise was hit by a vehicle and was killed. Once case involved the possible compromise of a gopher tortoise burrow. This case was turned over to the FWC for follow up.

Code Enforcement: Water Quality

The Code Enforcement Department issued a total of 30 notices for MS4 violations during the month of May 2024.

28 violations were for missing or damaged Silt Fences. 18 cases were corrected within the compliance deadline and 10 remain Open/Non-Compliant and will be scheduled for the Magistrate Hearing.

1 violation was issued for Illegal Dumping and corrected within the compliance deadline.

1 violation was issued for Illicit Discharge and remains Open/Non-Compliant. This case will also be scheduled for the

Magistrate Hearing.





