Re: March 2024 Monthly City Council Report

In March 2024, two Marco Island Police Department members were recognized for outstanding service to the City of Marco Island.

On March 4, 2024, Code Enforcement Officer James Muldoon was near Winterberry Park responding to a Code Enforcement violation when he heard commotion on the softball field. Upon response, he discovered a softball player who was having a medical emergency and in need of Basic Life Support. Code Officer Muldoon administered CPR which revived the male who was later transported to the hospital for further medical treatment. City Manager Mike McNees, Chief Tracy Frazzano, Code Supervisor Keith Richter, and Res/ Auxiliary Officer Ray Leshinger presented Muldoon with the "Caught in the Act" Award for his lifesaving efforts.





On March 20, 2024, Officer Josh Ferris was recognized as the Marco Island Police Foundation's 2023 Officer of the Year. Officer Ferris has served the City of Marco Island for over 12 years and has since received over 32 citizen commendations, 22 awards, and 50 advanced training certificates in a variety of specialized topics. In 2023, Officer Ferris took on the additional task of maintaining the department's armory. Officer Ferris developed an innovative and streamlined process which greatly improved the department's armory function. Officer Ferris' dedication to the City of Marco Island and its citizens is reflected in his willingness to take on additional tasks for the betterment of the department and its officers. Members of the Marco Island Police Foundation and Chief Tracy Frazzano presented Officer Ferris with the "2023 Officer of the Year" Award.

# March Police Activity Crime report:

In March 2024, 91 incidents were reported to the Marco Island Police Department. Total crimes against persons showed an increase of 20% due to a higher incidence of simple assaults. Property crimes decreased in March 2024 by 22% due to a reduction in thefts and criminal mischief incidents. Miscellaneous crimes showed an increase by 30% due to an increase in hit and run incidents. In March 2024, crimes against society, such as driving under the influence incidents showed a decrease by 33%. The Marco Island Police Department had 10 arrests in March of 2024 for incidents including DUI, criminal traffic for driving with no license, hit and runs, larceny, and an out of county warrant.


Note: Multiple criminal offenses may have occurred within some incidents.

This reporting aligns with new crime data collection requirements from the Florida Department of Law Enforcement and the FBI. This announcement for crime reporting was covered in the February 2022 monthly report.

Non-criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost and found items and medical assists.

#### 2023 vs 2024 Incident Crime Trends


In March 2024, there were 58 non-criminal incidents reported. 19% of non-criminal incident reports were comprised of suspicious activities. 4% of non-criminal incident reports were due to domestic disturbances, with no crimes occurring. 6% of reports were referencing assistance to other agencies including Collier EMS, Marco Island Fire Department, and other law enforcement agencies. 31% of non-criminal incident reports are for lost and found property. The Marco Island Police Department will accept found property into our property and evidence department for safekeeping until an owner can be located.



### **March Traffic Patrol**

Major Incident

In March 2024, there were 141 traffic citations and warnings issued by the Marco Island Police Department. Of the citations issued 27% were for failure to obey traffic signs or traffic lights. 22% were due to an excess in posted speed. 18% of citations were for operating a motor vehicle with an expired registration or driver's license. Other citations issued were for violations including safety belt infractions, improper passing, and illegal U-turns. In March 2024, the Marco Island Police Department arrested 7 people for traffic violations. The 7 arrests were comprised of 4 DUIs, 2 criminal traffic violation for driving with no license issued or no registration, and 1 hit and run notice to appear in court. 6 licenses were seized during traffic stops due to license suspensions or revocations.

#### March Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.

#### **Cases Closed by Detective Bureau:**

**Baker Act/Risk Protection Order** – Detectives initiated a Risk Protection Order with the City Attorney's Office regarding a mentally

disturbed subject who threatened suicide with a firearm.

**Lost Property** – Detectives took an initial report regarding a lost firearm. The firearm was entered as lost into nationwide/statewide databases.

Battery DV – A capias arrest warrant request was denied by the State Attorney's Office.

**Petit Theft** – An investigation into the theft of \$300 worth of oil was suspended and is considered inactive.

**Conveyance Burglary** – After follow-up investigation for available evidence, no suspect(s) could be identified. Case Inactive.

**Hit and Run Crash** – After the fact report from the parking lot of a business was determined to be unfounded. The driver identified themselves inside the local business and the other party was aware of his identity.

**Conveyance Burglary** – A follow-up investigation where no suspect(s) could be identified. The victim requested a report to document the incident but does not desire to prosecute. Case Inactive.

**Child Sexual Abuse** – Investigation into a tip regarding questionable material on social media. It was determined the material did not meet the elements of the crime.

**Suspicious Incident** – Detectives investigated damage by an apparent air gun.

**Criminal Mischief** – Detectives received a report of damage to a vehicle. After a review of local surveillance, no suspect(s) could be identified. Case Inactive.

Felony Battery – The SAO refused to issue an arrest warrant based on insufficient evidence to prove the felony in court.

**Petit Theft** – Detectives received a report of a stolen wallet. A citizen found the wallet which was turned over to MIPD with nothing missing and it was returned to the owner. Case unfounded.

**Fugitive from Justice** – Detectives arrested a suspect who had a warrant for his arrest for misdemeanor battery out of Franklin County, FL.

#### **March Marine Report**

Marine officers observed an increase of boater traffic this month as the weather started to improve. Officers conducted several patrols near and around Marco Island which resulted in 121 vessel stops and 33 boater assists/contacts. More than half of the vessel stops were concentrated in the Marco River due to several complaints from citizens of boaters traveling too fast in the area. Marine officers increased police presence in the area slowing down boaters. Boater stops were up 300% from last Month.

This month, Marine Sergeant Montgomery and Officer Smith also participated in a Marine Safety & Security Forum along with the Collier County Sheriff's Office, Naples Police Department, and Florida Fish and Wildlife.

On 3/26/2024, Sergeant Montgomery and Officer Marvin responded to a MERT call on Resident's Beach for a swimmer struggling on a raft floating out to sea. Upon investigation, officers located the raft which was unoccupied and had blown offshore while unattended. Sergeant Montgomery and Officer Marvin also responded to an additional report of a distressed swimmer who was unsuccessfully attempting to swim across Caxambas pass. The swimmer was located and safely returned to the beach.

On 3/29/2024, Sgt. Montgomery responded to Keewaydin Island for a medical call. Sgt. Montgomery arrived with MIFR and was able to utilize the shallow water capabilities of the Police Ranger to transport EMS personnel onto the beach to render aid to the distressed male.

#### **Beach Report**

March Beach events were down 4% compared to March 2023. With tourism season in full force, Code Enforcement Officers supported beachgoers by providing information and directions to ensure the safety of marine wildlife.



#### **Code Enforcement:**

In March, most of the Code Enforcement Violations concerned violations of the Trash Ordinance, Litter/Weeds, Silt Fence infractions and Right of Way Obstructions. City residents often contact Code Enforcement about right of way obstructions, and generally violations center around obstructing the right of way with materials in the swale. Of the total code calls for service this month, 89% were initiated by Code Enforcement Officers.



#### **March Special Magistrate Hearing**

This month's Special Magistrate Hearing took place on March 26, 2024. There were 28 cases scheduled to be heard. 25% of the scheduled cases were contested citations. Encroachment and weed violations represented 13% of the cases heard. Silt fence violations represented 10 % of the cases requiring a Magistrate Hearing for resolution.



## **Code Enforcement Protected Species**

This month there were 19 burrowing owl cases, all of which involved reported violations of the protection zone, (parking within 33 feet of the owl burrows). All cases were handled with education and verbal warnings, which resulted in voluntary compliance. There was 1 case involving Gopher Tortoises in March 2024 in which a vehicle parked too close to a Gopher Tortoise burrow. A citation was issued and placed on the vehicle which resulted in compliance within 24 hours. This month there were 7 cases involving shorebirds. Two Ospreys were discovered showing signs of distress and were unable to fly. Both were rescued and turned over to the Conservancy for treatment. There were three cases of shorebird flushing near the Marriott. Education and verbal warnings were issued. There were two other birds that were injured, one a Black Skimmer and one



Cormorant. Both were rescued and given to the Conservancy. On 4/17/24, we will be hosting our Sea Turtle open house from 5:00 to 7:00pm. There will be guest speakers from Collier County, FWC and Rookery Bay.

#### **Code Enforcement: Water Quality**

The MIPD Code Enforcement Department issued a total of 44 Notices for MS4 violations during the month of March 2024.

39 violations were issued for missing or damaged silt fences. 28 cases were closed after compliance, 1 case was unfounded upon investigation, and 10 remain open and will be scheduled for the next Magistrate Hearing.
3 violations were issued for Illicit Discharge violations. 1 case was closed after compliance, and two remain open and will be scheduled for the next Magistrate Hearing.

Additionally, 2 violations were issued for Illegal Dumping. Both cases remain open and if not corrected by the compliance date, will be scheduled for the next Magistrate Hearing.








