10 Events – including 3 vessel stops, 2 fish/resource cases and 1 vessel assist.

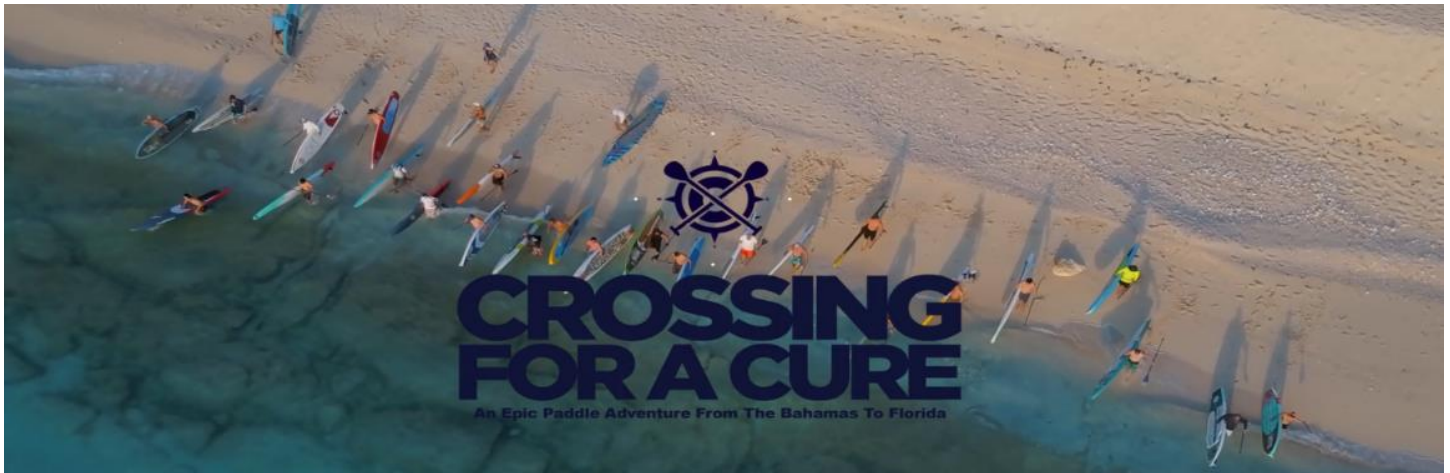
Beach Report
