Our organization represents the American Merchant Marine Veterans of World War II. It was founded in 1984 by several veterans of the Merchant Marine with the main purpose of gaining veterans benefits and title for the WW II Merchant Seamen. This mission was attained in 1987 and effective Jan 1, 1988 the sailors were granted veterans status equal to that of all other branches of the U.S. Military Service. At that time AMMV was host to 6000 veterans of WW II.

Our purpose continues to advocate for the Merchant Mariners both past and present in Peace and War and to educate and promote awareness of their contributions to our nation. In more recent years we were instrumental in obtaining the Congressional Gold Medal for Merchant Mariners of WW II, which was signed into law March 13, 2020, and has been distributed to living mariners of WW II as well as to the families of those deceased. We have taken WW II representatives to Washington DC to participate in the Laying of the Wreath at the Tomb of the Unknown Soldier on Memorial Day and Veterans Day. AMMV participates in the parades in Washington DC and elsewhere around the country honoring our veterans. Our members support and participate in Wreaths Across America each December where we honor the Merchant Mariners of WW II at cemeteries throughout the U.S. We have provided speakers for events all over the USA and in Europe to spread the word of the U.S. Merchant Marine which has participated in every war since its founding in 1775 including the Revolutionary War. This past June we erected a monument at Utah Beach to the Merchant Marine upon commemoration of the 80<sup>th</sup> Anniversary of D-Day.
