Re: August 2022 Monthly City Council Report

We continuously think of new ways to build meaningful, non-enforcement related experiences with our community. When the community has positive contact with law enforcement, perception of and shared interest in the community increases.

If you have school aged children, you've probably heard about our most recent community outreach program: Marco Island Police Department Trading Cards. School aged children have the opportunity to collect and trade different law enforcement officers, community service officers and administration staff. Those with full sets get a chance to win highly motivating prizes, kindly donated by the Marco Island Police Foundation. Children ask officers or a MIPD staff member for the card featuring that department member. Each card introduces the member, their role at the police department, and their inspiring quote. Children, their parents and MIPD staff members all have the opportunity to meet each other on a fun basis, all working together with a goal.

The competition started August 17 and news about the Trading Cards quickly spread through social media and coverage from the Marco Eagle, Coastal Breeze, the Chamber of Commerce and the Tommie Barfield PTA newsletter. By the end of August, 22 students had completed sets. Although this year's Trading Card experience comes to a close on September 17<sup>th</sup>, we're already planning a similar activity next year.

In August, we continued efforts towards the accreditation process with the Commission for Florida Law Enforcement Accreditation. The Marco Island Police Department is seeking certification by this independent reviewing authority. Law Enforcement agencies are reviewed on 235 prescribed standards and best practices for accreditation. Marco Island Police Department had 3 certified assessors representing the Commission come to our agency across August 23 – 25 to perform a Mock Assessment. This dress rehearsal helps prepare us for the formal Assessment that will occur later this year. Officers displayed vehicles, equipment and answered reviewers' questions regarding our policies. The assessors provided positive feedback. We look forward to completing our accreditation process with the formal, in-person assessment scheduled for December and later, the commissioners' panel hearing in February 2023.

## August Police Activity

### Crime report:

88 incident reports were written in August. The number of criminal offenses increased 64% versus the same time period last year; this is primarily due to an increase in the amount of criminal traffic activity. In August, the Marco Island Police Department arrested 15 individuals for offenses including domestic violence, criminal traffic (individuals operating a vehicle without a license with knowledge), resisting an officer with violence and pulling a fire alarm.

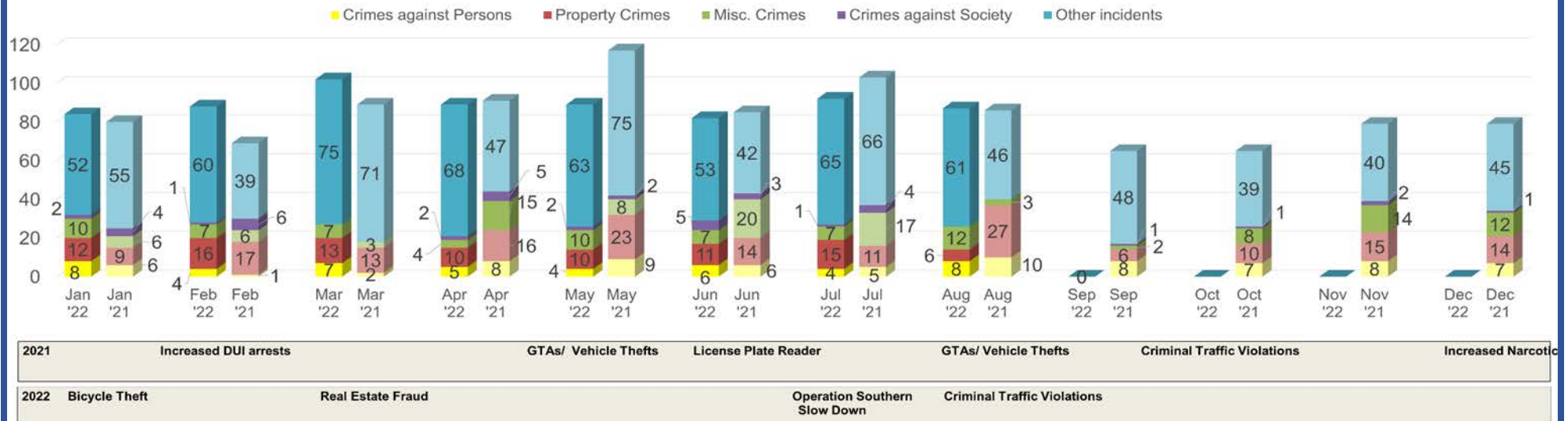

## 2022 vs 2021 Incident Trends

55 non-criminal incidents were reported in August. The majority of the non-criminal reports were for suspicious incidents (22%). Examples of suspicious incidents include the following but not limited to: civil disputes, suspicious phone calls and persons committing fraud outside Marco Island's jurisdiction. Lost and found property reports were the second largest number of non-criminal reports taken (20%) in August. Marco Island Police Department Officers assisted the Collier County Sheriff's Office investigators in arresting an individual with a warrant for aggravated animal battery.

by Crime Category, Non-Crime



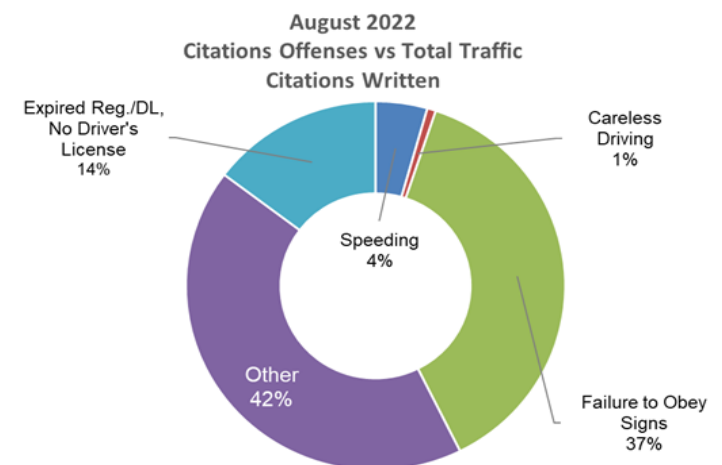
## Traffic patrol

309 traffic citations and warnings were issued in August.

Most citations were issued for failure to obey traffic control devices (stop signs, red lights, etc.).

This month, 20 citations were issued for driving with an expired registration or driver's license/ no driver's license. 9 infractions were non-criminal due to the motorists being unaware their licenses were suspended. 11 incidents, however, were criminal violations which consisted of drivers either never having a driver's license or were aware it was suspended.

14 driver's licenses and 4 license plates were seized by Marco Island Police Officers for driving with a suspended or cancelled license/ registration.

### Cases Closed by Detective Bureau:

**Credit Card Theft** – The Detective Bureau arrested a suspect for grand theft and misuse of personal identification.

**Death Investigation** – The Medical Examiner's report confirmed a decedent passed from natural causes.

**Child Abuse** – A joint investigation that had separate allegations occurring on Marco Island and the County could not be substantiated after the victim was interviewed.

**Assault** – The State Attorney's Office declined to file charges on a misdemeanor assault allegation.

### Follow-Up Reports from Patrol:

**Fraud** – A complaint filed for wire fraud was turned over to the FBI for investigation; MIPD will assist accordingly.

**Burglary Conveyance** – Investigation of a daytime burglary and \$30,000 theft from a Courier Service is ongoing.

**Burglary Residential, Attempted** – Despite follow-up, including a neighborhood canvas, this case has no investigate leads.

### Self-Initiated Reports:

**Cybertip** – A Cybertip was received from the National Center of Missing and Exploited Children. Investigation is ongoing.

**Found Property** – Detectives canvassing for leads on a suspect vehicle, found an abandoned Florida tag. A separate case number was generated, and the event documented.

**RPO Renewals** – The Detective Bureau is working on 2, Risk Protection Order Renewals from 2021.

**Operation Medicine Cabinet** – 106 lbs. of assorted prescription medications were removed from the public drop-off site and placed into evidence pending destruction.

**Suspicious Incident** – Detectives are investigating real estate fraud; no financial loss occurred with this case.

## August Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements.

## August Marine Report

During the month of August, marine officers continued attending to a significant increase of marine incidents due to an observed increase of boat traffic on Marco Island waterways.

Officers conducted vessel safety and sanitation inspections of anchored vessels in Smokehouse and Factory bays. Few vessels were anchored at these locations. All vessels were following Coast Guard regulations.

Marine unit officers responded to two marine emergency (MERT) calls during the month of August:

On August 13<sup>th</sup>, 2022, Officer Mike Garner responded to Caxambas Pass to assist three people on paddle boards that were stuck in the current and unable to paddle back to shore. All three individuals were recovered and safely transported back to shore.

On August 14<sup>th</sup>, 2022, Officer Mike Garner responded to Caxambas Pass on a report of a capsized kayak with two people in the water. Both individuals were pulled from the water along with their kayak and transported back to Caxambas Park without incident.

On August 21, 2022, Officer Marvin observed a large group of 15 manatees breeding off the south end of Marco Beach. Officer Marvin proceeded to set up a perimeter redirecting boaters and people away from the courting manatees.

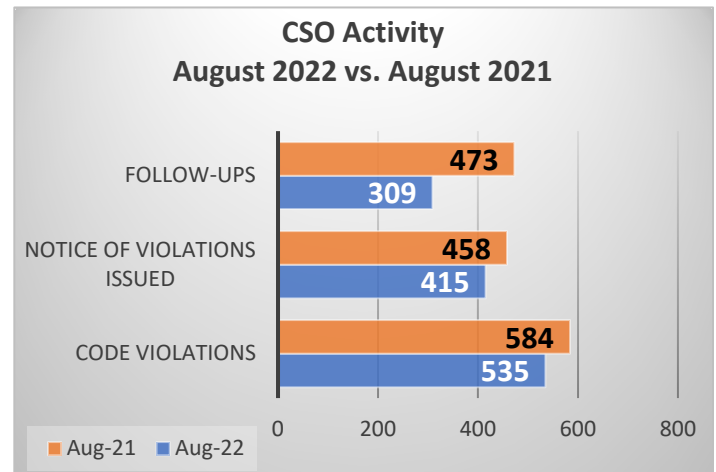

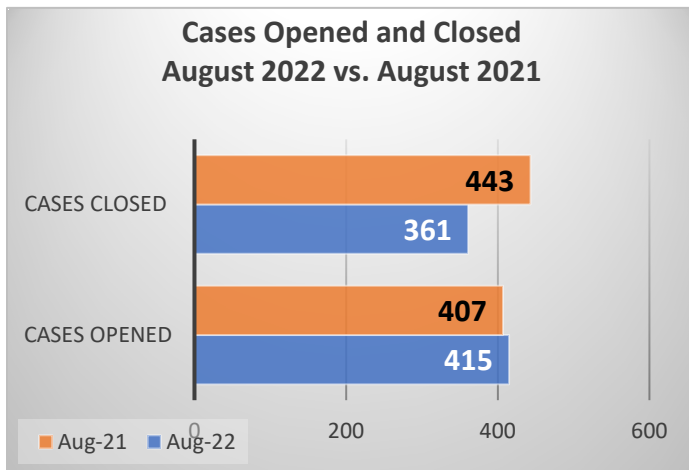
## August Code Enforcement:

Community Service Officer (CSO) incidents increased 17% compared to the same time last year. 78% of all Code Enforcement investigations resulted in an issued Notice of Violation.



## August 2022 Code Enforcement Cases

415 cases were opened in July, similar to the number opened during the same time last year. The largest number of code violations for the month of August were for trash on swale, overgrown weeds and roadway obstruction; a trend similar to July's issued violations. 7 valid noise violation occurred for the month of August.

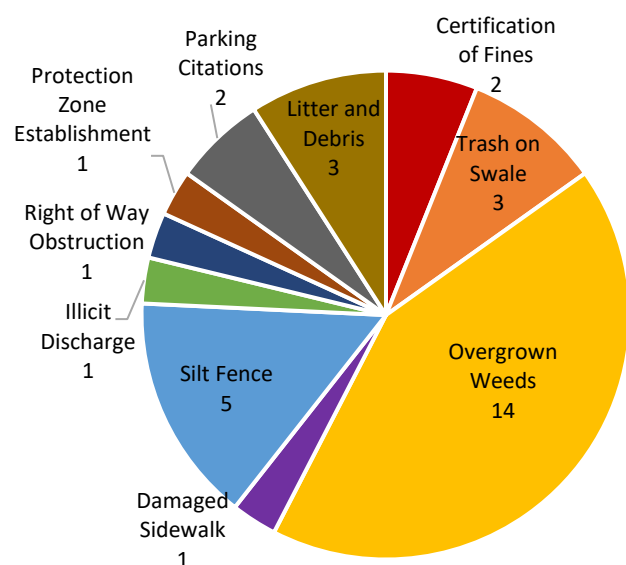

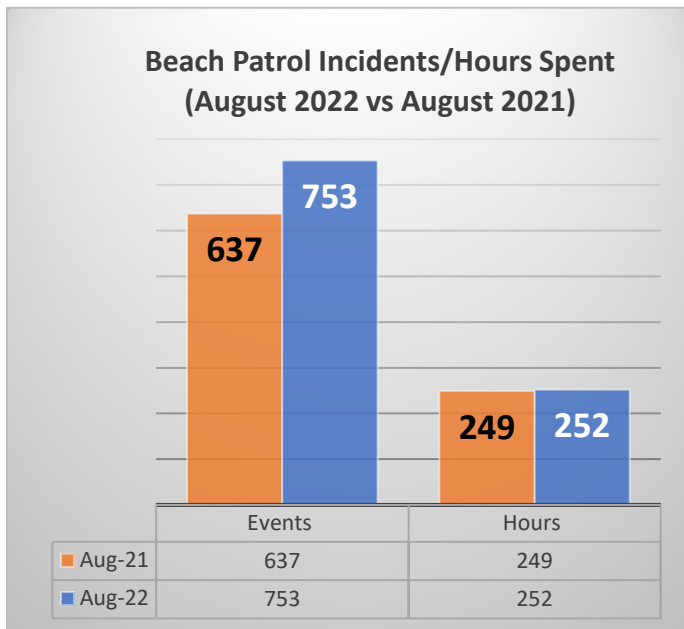
Over half of the cases (14 cases) were for overgrown weeds and 19% were for erosion control violations.

## **Beach Report**

Community Service Officers increased beach patrols with 50% more incidents this month versus last year. Glass on the beach was the top beach code violation this month. Officer patrols for Sea Turtle Nest protection increased 3-fold this month in comparison to last month.

## **Code Enforcement: Water quality**

The Code Enforcement Department continues to focus on Water Quality issues under the MS4 City Ordinance. The MS4 Ordinance focuses on controlling the introduction of pollutants to the municipal storm sewer system. This includes preventing construction site contaminants from waterways entry.

During the month of August, Code Enforcement issued 15 MS4 violations: one was for litter and debris, two were for illicit discharge, and twelve for silt fence violations. Of the 15 cases, four were found to be non-compliant and are scheduled for September Magistrate. The remaining eleven cases were compliant within the scheduled compliance dates.

As the rainy season comes to a close on September 30, we expect to see more fertilizer application in the upcoming months. Code Enforcement will check that contractors have permits and/or licenses.

There were no violations observed during August, for fertilizer application.

## **Code Enforcement Protected Species Update**

**Gopher Tortoises:** The month of August had no reported Gopher Tortoise issues or calls for service.

**Sea Turtles:** Sea Turtle nesting season runs from June 1st through October 31st.

By the end of August, Marco Island was reported as having 102 total nests, 205 false crawls and 44 total hatched nests. At the same time last year there were 97 total nests, 161 total false crawls and 48 total hatched nests.

Our night-time Code Enforcement Officers assigned to sea turtle monitoring, issued 4 Notice of Violations.

2 nests had their perimeters secured with caution tape by Beach Patrol CSOs.

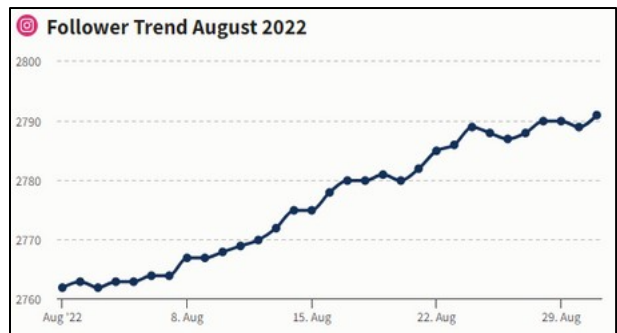
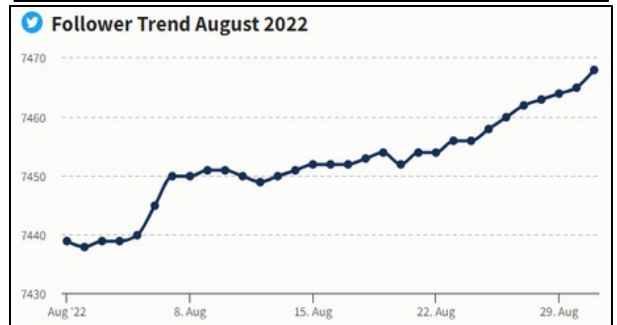
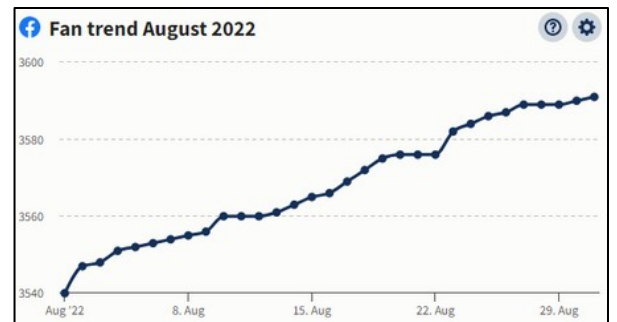
