Why do MPOs exist?

- MPOs are entities designated by Federal law:
 - 23 United States Code (U.S.C.) 134, 49 U.S.C. 5303, 23 Code of Federal Regulations
 - 450.310, and 339.175 Florida Statutes
- MPOs exist in all urban areas over 50,000 in population, **if** the agencies in that area spend federal money on transportation improvements.
- MPOs are responsible for the development of the area's Long Range Transportation Plans, Transportation Improvement Program, Unified Planning Work Program and for coordinating the Transportation Planning Process.
- The Collier MPO was established in 1982



- MPOs are highly regulated and subject to FDOT, FHWA, and FTA oversight.
- The Transportation Planning Process requires public involvement, transparency, data-driven analysis, and reporting on national performance measures.

Mission & Vision



- MISSION: To provide transportation planning leadership through a collaborative effort to maintain a safe, efficient, integrated and multi-modal transportation system.
- VISION: to provide a fully integrated and multimodal transportation system that safely and efficiently moves people and goods while promoting economic development and protecting natural and man-made regional assets.








2050 LRTP: completion date December 11, 2025


Bureau of Economic and Business Research medium projection: additional 92,800 population by 2050




Population Change in 5-year Increments




Primary Growth Areas

I-75/SR 951 (Collier Blvd) Interchange Improvement underway	\$ 97 million
I-75 at Pine Ridge Rd Interchange Improvement FY 2025	\$ 24 million*
I/75 widen from 6 - 8 lanes from Golden Gate Pkwy to Corkscrew Rd (Lee County), FY 2027	\$578 million*
SR 29 from New Market Rd to SR 82 FY 2027	\$ 59 million*
SR 29 from CR 846 E to New Market Rd, new alignment, 4-lane divided loop around downtown Immokalee FY 2027	\$84 million*


