SIGNIFICANT CASE INFORMATION/INCIDENTS:

Trespass 1361 Andalusia Terrace (Mackle Park) Unknown suspect removed tape over an opening where a portable AC unit was and gained entry. No items taken. Possible homeless person spent the night. *No suspect information, no video surveillance, no theft. Case Inactive*

Burglary of Conveyance / Grand Theft 870 Collier Ct – Theft of fishing equipment from a 24-foot Skeeter model boat. Unknown suspect entered two unlocked compartments on the front of the boat and removed two tackle boxes with tackle and two rod/reel combos. Value for loss is approximately \$1,400. *No suspect information, no video surveillance. Case Inactive*

Grand Theft 176 S Collier Blvd – Condo owner reported loss of jewelry that consisted of rings and earrings. Value for loss is approximately \$7,200. List of workers was provided and checked. Items checked through pawn shop search. *No suspect information developed, no video surveillance. Case Inactive*

Traffic Crash 800 Bald Eagle Dr – Driver had a medical emergency and accelerated through two parking lots where a female was struck and severely injured while getting in her car. Information report taken with CCSO THI unit taking the lead. *Video surveillance collected and turned over to CCSO THI. Case Closed*

Burglary of Dwelling 560 Nassau Rd – Homeowner returned home from a doctor's appointment to discover her home had been burglarized. A neighbor saw a suspicious vehicle described as being a dark blue four door vehicle possibly occupied by a large black subject around this time. Taken was a computer, jewelry, and cash. Value for loss is approximately \$21,565. *Suspect information, no video surveillance, Pending Investigation*

Fraud 486 Landmark St – Victim responded to a Publisher's Clearing House sweepstakes scam. Victim sent two \$60,000 cashier's checks to a suspect with them being cashed at two separate banks in Tallahassee. *Subpoena has been issued for bank records, Pending Investigation*

Death Investigation 767 Amber Dr – Deceased 50-year old male who died alone in his home. He was out with friends at a local restaurant/bar and complained of not feeling well. Family reported that he had some medical issues that he was not taking his prescribed medication. *Surveillance video obtained from the restaurant, Pending Medical Examiner Review.*

Burglary of Conveyance / Grand Theft 385 Angler Ct – Victim left his 24-foot Skeeter locked at his slip. He came back and the compartments were unlocked, and his rod/reels were missing. Reported that boat manufacturer uses universal keys. Value for loss is approximately \$5,500. *No suspect information developed, no video surveillance. Case Inactive*

Criminal Mischief 1003 Angler's Cove – Unknown suspect broke off victim vehicle wiper blades and poured sand all over his vehicle. Estimated damage is \$300. *No suspect information developed, no video surveillance. Case Inactive*

Criminal Mischief 308 Castaways Ct – Unknown suspect kicked and damaged victim's mailbox. Estimated damage is \$150. *A possible suspect was located in the area by Patrol however victim could not positively identify, no video surveillance. Case Inactive*

Grand Theft 140 Seaview Ct – a men's and women's bicycle was stolen with a total loss of about \$778. Jamis brand bikes with serial numbers provided by owner. *No suspect information, no video surveillance. May be related to other cases that occurred in March. One case has a suspect which is being actively pursued. Bicycles were entered NCIC/FCIC. Pending Investigation.*

Grand Theft 140 Seaview Ct – a men’s and women’s bicycle was stolen with a total loss of about \$4,000. Both were Magnum brand bikes with a serial number for only one. *No suspect information, no video surveillance. May be related to other cases that occurred in March. One case has a suspect which is being actively pursued. Bicycle was entered NCIC/FCIC. Pending Investigation.*

Violation of Injunction / Misuse of 911 159 Stillwater Ct – Adult female harassing family member of a petitioner who has a restraining order against the suspect. Suspect called in numerous emergency calls to include a false “shots fired” call. *Submitted for charges and SAO issued a Capias Warrant for Misuse of 911. Case closed by arrest.*

Grand Theft 1361 Andalusia Terrace (Mackle Park) – Victim left his Samsung phone on a ledge in the game room. Phone was taken by unknown female suspect and valued at \$1,200. *Suspect is seen on park surveillance, Serial number for phone is entered FCIC/NCIC. Pending Investigation.*

Grand Theft 1108 S Collier Blvd – Complaint of rental company taking owner’s rental proceeds. Loss is approximately \$5,244. *Pending Investigation.*

Grand Theft 140 Seaview Ct – a men’s bicycle was stolen with a value of about \$500. Bicycle was a Trek brand with no serial number available. *No suspect information, no video surveillance. May be related to other cases that occurred in March. One case has a suspect which is being actively pursued. Pending Investigation.*

Petit Theft 56 Greenbrier St – A Denali brand men’s bicycle valued at \$200 was taken from the Mariner condos bike rack. No serial number available. *No suspect information, no video surveillance. May be related to other cases that occurred in March. One case has a suspect which is being actively pursued. Pending Investigation.*

Grand Theft 140 Seaview Ct – a men’s Felt brand bicycle was stolen with a value of about \$500. No serial number available. *No suspect information, no video surveillance. May be related to other cases that occurred in March. One case has a suspect which is being actively pursued. Pending Investigation.*

Grand Theft 140 Seaview Ct – a bicycle rack for the back of a car was stolen. Yakima brand rack valued at \$700. Suspect vehicle description matches the suspect vehicle in a later Bike theft. *No suspect information, no video surveillance. May be related to other bicycle cases that occurred in March. One case has a suspect which is being actively pursued. Pending Investigation.*

Grand Theft 720 S Collier Blvd – a Jamis brand ladies’ bicycle was stolen from the bike rack. Surveillance video developed a suspect vehicle which is a 2002-2006 Mini Cooper, green in color, with white roof and mirrors. Vehicle is occupied by two. Suspect who took the bicycle from the rack appears to be a Hispanic male wearing a pink shirt, black pants, black shoes, and baseball cap. The bicycle is valued at \$500. *There is suspect information, a video surveillance recording, and the bicycle serial number has been entered in FCIC/NCIC. May be related to other bicycle cases that occurred in March. Pending Investigation.*

Petit Theft 571 E Elcam Cir – Wallet stolen out of a purse at a gym. Loss of ID, debit card, and \$30. *No suspect information, no video surveillance, Pending Investigation*

Grand Theft Firearm 1124 Whiteheart Ct – Handgun stolen from residence and ex-roommate is suspect. Firearm valued at \$400. *Pending Investigation.*

Video Voyeurism 2255 San Marco Rd – Assisted School Resource Officers with their investigation. *Cleared by Arrest, Evidence collected, Juvenile NTA*

Grand Theft 39 N Collier Blvd - An unknown brand men’s bicycle, purple in color was stolen from the condo bike rack. Bike was valued at \$500. Per the owner. *No suspect information, no video surveillance. May be related to other cases that occurred in March. One case has a suspect which is being actively pursued. Pending Investigation.*

Petit Theft 220 Seaview Ct – A Diamondback brand Maravista model bicycle was stolen from the victim’s parking spot in the garage. Bicycle valued at \$200 and owner had a serial number. *No suspect information, no video surveillance. Serial number was entered FCIC/NCIC. May be related to other cases that occurred in March. One case has a suspect which is being actively pursued. Pending Investigation.*

Suspicious Fire 1128 Edington – A home under construction burned under suspicious circumstances. Assisted State Fire Marshall as evidence was collected. Laboratory analysis is underway and surveillance video is being evaluated. *Video surveillance available, State Fire Marshall is lead. Pending Investigation.*

Sexual Battery 586 Goldcoast Ct – Eight college students were staying at location for spring break. Victim reports that Incident occurred after a night of drinking alcohol beverages. *Known suspect, Pending Investigation.*
