Events

- Special detail officers were requested by JW Marriott for their Roadhouse concert series
 April 28 through May 1st. MIPD Officers provided a total of 310 hours of beach and event
 security over the three days while still meeting normal operational requirements.
- May 1st began Sea Turtle Season. Officers are patrolling our beaches to ensure the safety
 of this endangered species. Each May and continuing through early August, female
 loggerhead sea turtles crawl out of the Gulf of Mexico and nest on Marco
 Island's beach. The baby turtles, or hatchlings, will emerge after the nests are laid.
 Hatchlings generally are emerging from early July through the end of October each year.
 The season ends October 31st. During this time residents are subject to Beach Lighting
 Law Compliance, keeping beach free of barriers, and reporting injured or dead turtles to

- the proper authorities. Sea turtle season details were posted on department social media and the City's website. A Community Service Officer has been assigned to conduct periodic night patrols to ensure compliance with lighting restrictions.
- May 5th began Hurricane Preparedness Week. It is time to evaluate what you need to do to protect your home and family NOW, before the first storm of the season forms.
- On May 16th members of the MIPD attended Police Officer Memorial Week service in Naples.
- May 20th began the statewide "Click it or Ticket" campaign which will be in effect through June 2nd. After the two-week enforcement period of our "Click it or Ticket" operation, a post survey was conducted which revealed 92% of motorists and front seat passengers were in compliance! MIPD conducted 311 traffic stops during the initiative.
 - √ 28 warnings for seatbelts
 - ✓ 6 citations issued for seatbelts
 - √ 33 citations issued for other violations
- Coffee with the Chiefs was held at Dunkin' Donuts May 21st. Chief's Schettino and Murphy were in attendance as well as many other officers and fire fighters. Staff had many opportunities to interact with the public.
- PD Honor Guard was present at Marco Island's Memorial Day Ceremony May 27th.
- May 31st marked the retirement of Chief Al Schettino after ten years of service to Marco Island, and four decades in law enforcement. At the same time, Captain Dave Baer was named as our Acting Chief.
- In an effort to preserve our water quality the Department seeks to remind others of the
 restrictions regarding fertilizer application. "Timing of Fertilizer Application." No
 applicator shall apply fertilizers containing nitrogen or phosphorous to turf and/or
 landscape plants during the rainy season (June 1 September 30) and the prohibited
 application period to saturated soils." Public education regarding fertilizer was affected
 by posting a variable message board at the Jolly Bridge, utilizing Department social media
 and the City's website.

Burglary Dwelling 773 Holly Court – Unknown suspect(s) entered home and removed several electronics and appliances totaling in approximate loss of \$9,000. Ongoing investigation

Carry a Concealed Weapon & Possession of Narcotics 695 Bald Eagle Drive — Officers were advised of a suspect brandishing a firearm inside a bar. Officers made contact with the suspect and conducted an investigation. Probable cause was established to arrest the suspect for carrying a concealed weapon.
