Recognition

Marco Island Firefighter Dirk Switken, along with members of North Collier Fire Rescue, took first place (Soccer) in the 2019 Florida Firefighter Games. The event was held in Tampa, June 13-15. This year the team won all 6 games, scoring 34 goals and only giving up 5.



EMS

Staff finished the new CCEMS Interlocal agreement (MOU), which will be going before City Council for approval. The document is on the County's agenda for the June 9th meeting.

Items of Interest

- On June 5th, Staff attended the Collier County Chief's Association "Data Committee" meeting.
- On June 12th, Staff attended the County Emergency Medical Authority (EMA) meeting.
- On June 12th, Staff attended the CCEMS Protocol Sub-Committee meeting.
- On June 19th, Staff attended FEMA G-191 "EOC Interface with Emergency Management" training class at the County EOC.
- On June 20th, Staff attended the County Operations & Communications Meetings.
- On June 21st, Staff attended the EMS Council meeting.
- On June 24th, Staff attended the Collier County Chief's Association meeting.
- On June 24th, Management held Field Training Paramedic (FTP) interviews, to replace the position vacated.
- On June 26th, Staff attended the monthly Officer's meeting.

Significant Incidents

- On June 2nd, Fire crews responded to a vehicle roll-over on Yellowbird, involving an electric pole. Power to the area was shut down to remove the victims: only minor injurers were reported.
- On June 5th, Fire crews responded to a minor dumpster fire in the Bayport Ave. area.
- On June 12th, Crews responded to the N. Collier Blvd area for a vehicle accident. The Accident caused major road blockage; only minor injuries were reported.
- On June 28th, Fire crews responded to a boat fire (at the dock) in Goodland. No other vessels were involved, and no injuries were reported.
- For the reporting period, Fire Boat Crews responded to 10 MERT incidents. These included- a female with a back injury near Johnson Bay, a fully involved vessel 24-miles west of Marco Pass (with 2 people in a raft), 4 subjects in the water in Caxambas Pass, 9 people removed from 2-boats (1.5 miles off of the beach) during a severe storm, and 3 paddleboarders who were stranded in the Rookery Bay area.

Public Education/Community Outreach

- June 3-7 Staff conducted the Police Fire Youth Academy teaching students the various duties and skills required to be a Police Officer or Firefighter. This annual summer program has proven to be a great success with a waiting list of applicants each year.
- On June 20th, Crews assisted at Mackle Park's summer camp during "Water Day"
- During the month of June, Staff certified 12 CPR Students during 2 class.



Incident Volume and Emergency Incident Overlap

The Fire Rescue Department responded to "244" emergency incidents during the month of May. During this month, the Department experienced "64" overlapping emergency incidents.

(Overlapping incidents occur when the department has more than one incident response going at the same time. This is an important data point to track as some incidents require more than one fire department unit to respond and having two or more calls overlapping could result in a situation where not enough units are available for response)

Response Survey Cards

The Fire Department sends a survey card to individuals who call 911 for an emergency. These cards allow the end user to rate the performance of our personnel, as well as, the Emergency Room care and 911 dispatch system.
