1 **ORDINANCE NO. 20-XX** AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA, 2 ADDING TO THE LAND DEVELOPMENT CODE OF THE CODE OF ORDINANCES, IN 3 ARTICLE II, ZONING, CHAPTER 30-60, PROHIBITING THE SALE, MANUFACTURING, 4 5 CULTIVATION, DISTRIBUTION, AND WAREHOUSING OF RECREATIONAL MARIJUANA IN ALL ZONING DISTRICTS IN THE CITY OF MARCO ISLAND; AND 6 AMENDING IN ARTICLE 1, GENERAL, CHAPTER 30-10, SUB-SECTION (C) TO 7 PROVIDE A DEFINITION FOR "RECREATIONAL MARIJUANA"; PROVIDING A 8 9 CONFLICTS CLAUSE, SEVERABILITY CLAUSE, AUTHORITY TO CODIFY, AN EFFECTIVE DATE; AND FOR OTHER PURPOSES. 10 WHEREAS, the City of Marco Island's Land Development Code needs to be updated and 11 revised to "PROHIBIT THE SALE, MANUFACTURING, CULTIVATION, DISTRIBUTION, AND 12 WAREHOUSING OF RECREATIONAL MARIJUANA IN ALL ZONING DISTRICTS IN THE CITY OF MARCO 13 ISLAND"; and 14 WHEREAS, the City Council of the City of Marco Island, Florida, finds the enclosed ordinance 15 is consistent with the latest version of the Marco Island Comprehensive Plan. 16 WHEREAS, the City Council of the City of Marco Island has determined that the proposed 17 revisions to the Land Development Code are in the best interests of the general welfare of the City. 18 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, 19 20 FLORIDA, that: Section 1. The above recitals are true and correct and are hereby incorporated into this 21 22 Ordinance as if fully restated herein. Section 2. Section 30-10, sub-paragraph (c) of the Land Development Code of the Code of 23 Ordinances of the City of Marco Island, Florida, Definitions, shall hereby be amended to include the 24 25 following definition: Recreational Marijuana - The cultivation, manufacture, warehousing, distribution and sale of 26 Marijuana or any derivative or synthetic form of Marijuana, and paraphernalia associated with 27 Marijuana use, excepting any Hemp derived products (including CBD products) containing 0.3% or 28 less of THC (dry weight), as defined and described in the Federal Agricultural Act of 2018. Also 29 exempted is Medical Marijuana, as defined in the State of Florida Statutes. 30 Section 3. Section 30-60 of the Land Development Code of the Code of Ordinances of the 31 City of Marco Island, Florida, shall hereby be added to read as follows; 32

34	(a) Uses specifically prohibited in all zoning districts, as listed in the Marco Island Code of		
35	Ordinances, Chapter 30, Article II, Zoning, Division 2 through Division 13, including		
36	prohibiting uses resulting from any Variances and/or Conditional Uses and/or Planned Unit Developments. The following uses are deemed highly inappropriate for the small urbanized, island of Marco Island, Florida, and are inimical to the public health, safety.

42 43	 Recreational Marijuana as defined in Land Development Code Section 30-10, sub section (c).

45	Section 4. Section 30-222 of the Land Development Code of the Code of Ordinances of the		
46	City of Marco Island, Florida, shall be amended as follows;		
47	Delete NAICS Code 453998 (defined as "Medical and Recreational Marijuana") from item		
48	number 29 and insert Medical Marijuana as a permitted use, as shown directly below:		
49 50	(29) Miscellaneous store retailers (Groups 45311, 45321, 45322, 45331, 45391, 45392, 453991 , 453998) and Medical Marijuana.		
51	Section 5. All ordinances or parts of ordinances in conflict herewith be, and the same are		
52	hereby repealed.		
53	Section 6. This Ordinance shall become effective immediately upon its passage on second		
54	and final reading of the Marco Island City Council.		
55	Section 7. The Ballot Title of this Ordinance is "Prohibit Selling, Cultivating, Distributing		
56	Recreational Marijuana on Marco Island, excluding Medical Marijuana and CBD Products"		
57	Section 8. In accordance with Florida Statute 106.161(1), the Ballot Summary (for Ballot use only) is		
58	provided for the subject Ordinance as "Shall the City of Marco Island enact an Ordinance of the City adding		
59	to the Marco Island Land Development Code of the Code of Ordinances, Article II. Zoning, Chapter 20, 60		
60 51	prohibiting the sale, manufacturing, cultivation, distribution, warehousing of Recreational Marijuans in all		
51 62	zoning districts in the City. Amending Article I, General, Chapter 30-10, Sub-Section (c) providing definition for "Recreational Marijuana", and excluding Medical Marijuana and CBD products from the Prohibition"
