Re: 2020 June Monthly City Council Report

We continued our safety operations as it relates to the coronavirus (COVID-19). This included consistent monitoring of the different informational platforms and being involved in the planning and response efforts as it relates to routine calls for service and COVID-19 events. The Police Department, in support of citizen's rights to peacefully protest, partnered with the Collier County Sheriff's Office in ensuring the safety of the public and those protesting on June 4. The protest started at Veteran's Park, made its way to City Hall and ultimately ended back at the park after stops along the way at various intersections. Members of the Police Department worked with other city departments and emergency management in preparation efforts for tropical storms, hurricane season, and the July 4th holiday weekend. Collaboration continued as it applied to revision of the Sea Turtle Ordinance. Staff was involved in budget meetings throughout the month that led to a successful budget presentation to the City Council. Technology was again utilized to assist in the interviewing process for potential employees. This month, we were able to successfully hire two new Community Service Officers.

Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our Department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements. The below chart signifies the logged hours that have been devoted to the particular assignment by the Reserve and Auxiliary Officers.

Detective Bureau Monthly Report

INVESTIGATIVE SUMMARY:

Self-Initiated Reports:

DCF – Allegation about a father. Contact was made with DCF and the allegations were unfounded.

Trespassing – Juvenile subjects were issued trespass warnings from Calusa Island Marina for suspicious activity.

DCF – Allegation about a child not being cared for by parents. Contact was made with DCF and the allegations were unfounded.

Trespassing – Unknown suspect(s) trespassed into the Key Marco community to go fishing at the dock.

Criminal Mischief – Unknown suspect(s) used a vehicle to push through the Key Marco gate and trespassed onto the property. The gates opening/closing mechanism was damaged.

DCF – Allegation about pregnant mother doing drugs. Contact was made with DCF and the allegations were unfounded.

Open Carry of Firearm – Detective arrested a male subject for open carry of firearm during a civil protest.

Lewd and Lascivious – Allegation made about an adult having sex with a child. The suspect was located and arrested. The suspect is currently being held on a \$50,000.00 bond and has an ICE hold. Cleared by arrest

Grand Theft – Bald Eagle Drive – Unknown suspect(s) stole a ranger boat trailer. Case inactive

Fire – A fire occurred in the kitchen at one of the apartments at the Island Manor Condominiums. There was minimal damage. The cause of the fire was found to be an accident.

Threats – Local realtor complained of threatening phone calls to her employer and herself. Report documented and closed.

Death Investigation - Decedent with history of alcohol abuse found unattended at his home. Case is active pending results from the Medical Examiner.

Vessel Burglaries – After receiving credible intelligence, suspects have been developed for a string of vessel burglaries that occurred at Calusa Island Marina over the last six months. 7 stolen fishing rods have been recovered and the case is ongoing.

Stolen Checks – Three active cases for stolen checks are being investigated.

Through further investigation it was determined that subjects were assisting an out of area appraisal company for a refinance applied for by owner. Case unfounded.

DID YOU KNOW THAT ON AVERAGE THERE ARE 80 LOGGERHEAD SEA TURTLE NESTS PER YEAR ON MARCO ISLAND?

Each May and continuing through early August, female loggerhead sea turtles crawl out of the Gulf of Mexico and nest on Marco Island's beach. The baby turtles, or hatchlings, will emerge 60 days after the nests are laid. Hatchlings generally are emerging from early July through the end of October each year.

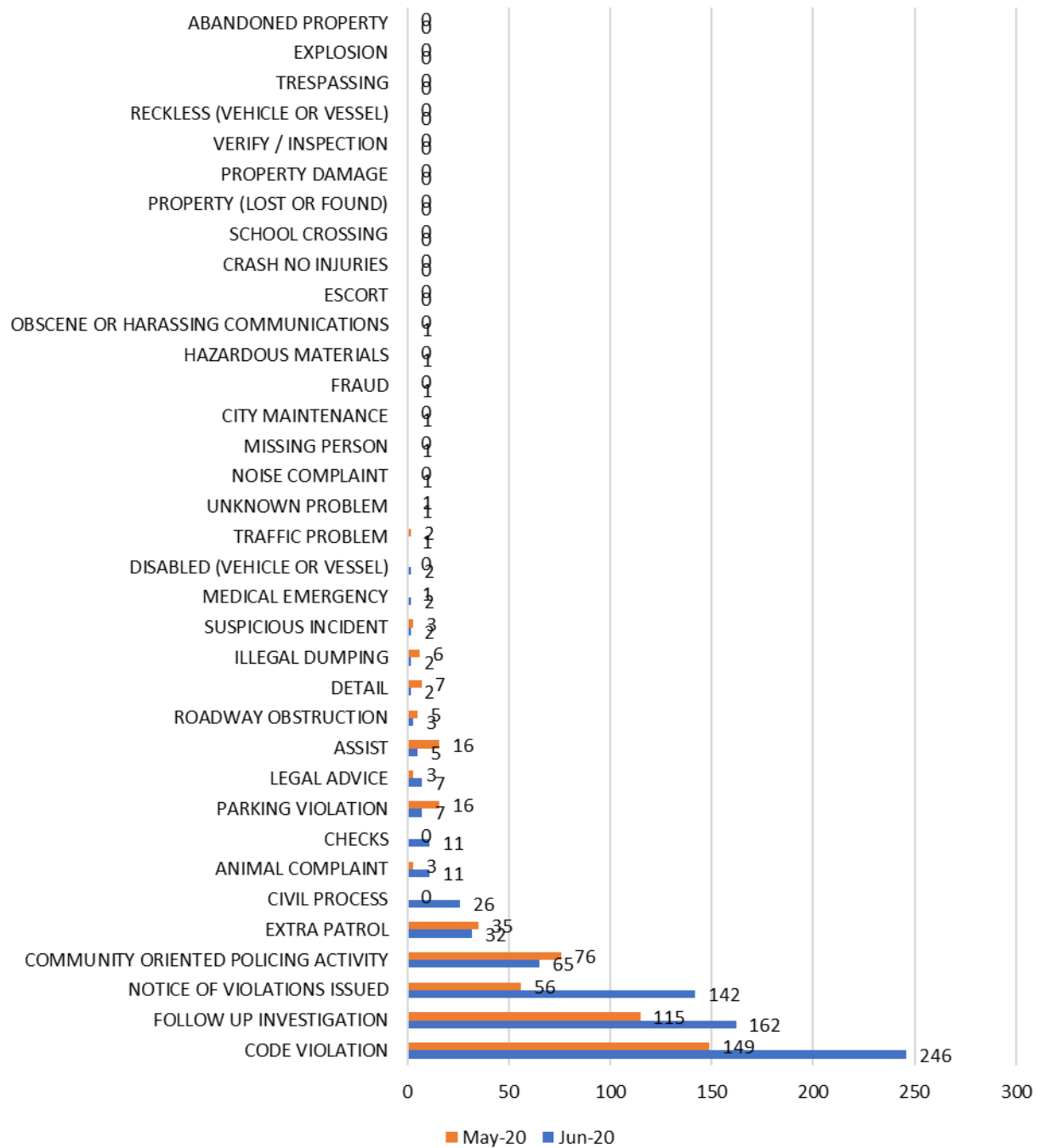

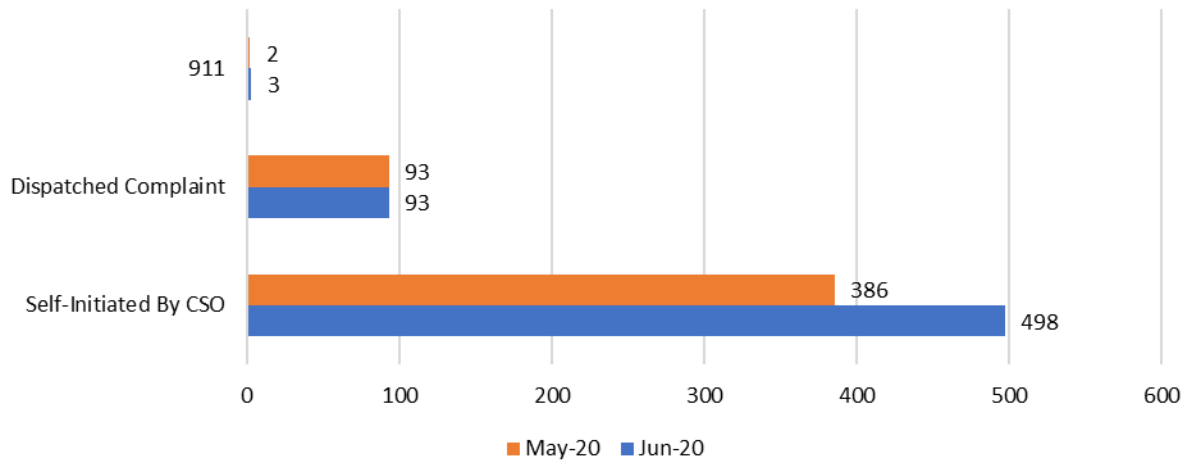
Sea Turtle Activities Overview

- Conducted false crawl investigation.
- Collaborated with FWC regarding construction on the beach during sea turtle nesting season
- Provided sea turtle weekly statistics to our beachfront condo partners
- Mid-June received positive feedback from Collier County Turtle monitors on the cleanliness of the Marriott and Hilton beach
- Consulted with Collier County Turtle Monitors and Collier County Environmentalist to establish double barriers in crowded beach areas to give a more robust 25-foot sea turtle nest protection zone
- Worked with multiple Beach Committee members.
- Investigated a report from the city environmentalist regarding a damaged nest - determine there had not been any damage.
- Worked with Public Works regarding street light shielding.
- Worked with LCEC regarding light shielding.
- Developed turtle log: locations of each nest by coordinates and anticipated hatch date – use to notify nearby properties to be extra vigilant
- Alerted all beach vendors of their responsibilities to clear the beach of property and/or equipment every evening - false crawl prevention.

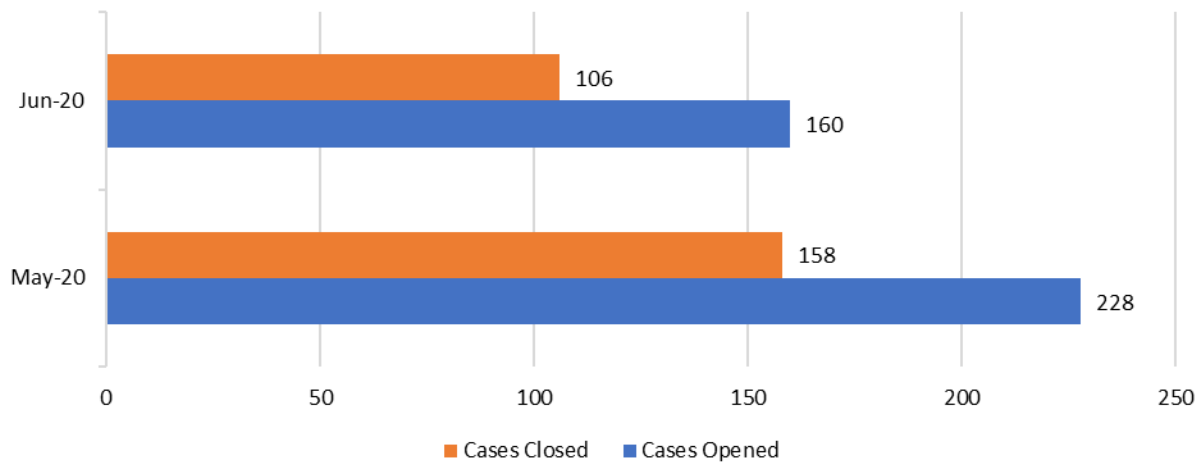
June 2020 CSO CAD Activity



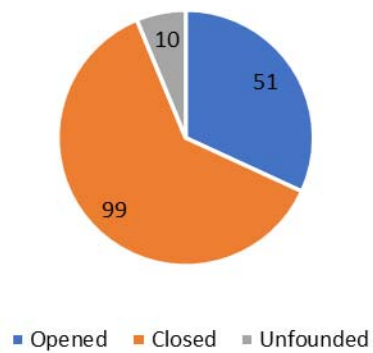
June 2020 CSO Activity by Source
