For 8 years a member and the current president of Ville de Marco West Condominium Association. As president, oversaw the multi-million dollar replacement of the seawall at the intersection of Collier Creek and the Marco River that was destroyed by hurricane Irma..

In full disclosure, On June 8th, 2017 testified before the Coastal Advisory Committee warning of dangerous fast-moving waters in Collier Creek caused by the movement of sand over a jetty which narrowed the creek. With the support of our Condominium Board, we spent many hours on the proposal to widen the entrance into the Creek from the Marco River. Since then, the CAC has developed a plan to relocate the Jetty and sand on the Western bank to widen the mouth of the waterway. A study showed it would lessen turbulent waters that are a danger to marine life and the 40% of Marco Island boaters who use waterway to reach the Gulf. Whereas the implementation of this plan could affect water adjacent to our condominium, I do not view it as a conflict as it would improve boating safety and navigation and wildlife protections.

Currently the District Deputy for the Knights of Columbus for this area of SW Florida, a major fundraising organization for the needy on Marco Island and in Collier County.

As a member of the American Cancer Society's Volunteer Leadership Board, coordinating fundraising and an information outreach for the Society. I have driven for the Road to Recovery program which transports cancer patients to their doctors, chemotherapy, radiation or other therapies.
