Re: Fire Rescue Monthly Report

Significant Incidents

- On Mar 3rd, crews responded to the S. Collier Blvd. area for a vehicle vs pole. The vehicle sustained major damage and 1-subject was transported to the hospital.
- On Mar 5th, crews responded to a 2-car accident on N. Collier Blvd., moderate damage and three subjects were transported to the hospital.
- On Mar 6th, crews responded to Collier Blvd. & San Marco Rd. for a vehicle vs pedestrian.
- On Mar 16th, fire crews responded to Caxambas Park, 60 gal of fuel was accidently pumped into the bilge of a boat, crews mitigated the hazard.
- On Mar 22nd, Fire crews assisted GNFD with a moderate sized brush fire on Tamiami Trail east.
- On Mar 24th, fire crews responded to a small brush fire in GNFD district, just off San Marco Rd.
- On Mar 27th, crews responded to a 2-car accident at Collier Blvd. & Barfield Dr., minor damage including significate road blockage.
- On Mar 28th, crews responded to the Collier Blvd. south area for a motorcycle vs pole. The subject was trauma alerted to Lee Memorial Hospital.
- On Mar 29th, fire crews responded to an air conditioner fire in the Leeward Ct area. The fire was extinguished with damage to the A/C unit only.
- On Mar 30th, crews responded to a shooting in the 1st Ave. area, minor injuries reported.

Marine Incidents

For the reporting period, the Fire Boat responded to 10 MERT incidents. These included- a 37' vessel that hit a channel marker, a boat taking on water 13 miles west of Marco Island, a 35' vessel that ran aground in Caxambas Pass, a capsized boat in Henderson Creek with subjects in the water, an overturned boat near Gordon Pass with 2 people in the water, a medical emergency on Cape Romano and a medical emergency on Keewaydin.
