The Planning Board/Local Planning Agency held a public hearing and reviewed the draft Comprehensive Plan transmittal at their June 4, 2021, meeting. The elements reviewed were as follows:

- Future Land Use
- Transportation
- Housing
- Infrastructure
- Conservation and Coastal Management
- Parks, Open Space and Recreation
- Intergovernmental Coordination
- Capital Improvements
- Glossary
- Map Series

The Planning Board suggested a few changes that are noted in the draft provided to the City Council.

During the public comment section there were a few people that spoke about archeological, environmental, intent of the plan, what the citizens want, word smithing, small town charm affordable housing. The people that spoke were Gene Erjavec, Nancy Richie, Brad Cornell, Maria Lamb, Terry Sommerfeld, and Christine Arndt.

They voted 6-0 to forward a recommendation of approval to transmit to the State for their review.

The City Council was sent the draft transmittal on Friday, July 2, 2021, in advance of the July 19, 2021 meeting. Paper copies are also available for pick up at City Hall.

SUMMARY OF EVENTS

The City's current Comprehensive Plan was adopted in 2009. Since then, there have been many changes, including the City's built-out environment, relevant state statutes, and the City's population.

As a result of the changes, the City Council authorized the allocation of funds for a planning consultant to help the City update the Comprehensive Plan. We requested qualifications, and after an internal review, ranking and interviews of the top candidates, the team of Dr. Margaret Banyan of Florida Gulf Coast University and Alexis Crespo, AICP with Waldrop Engineering was selected.

The last year and a half, have been busy with public outreach, public meetings, receiving input and compiling the input into the draft elements that were further reviewed. Below is a summary of various meetings, town halls, and outreach.

PLANNING BOARD REVIEW AND ACTION

This is the first step in transmitting the draft update of our Comprehensive Plan to the Florida Department of Economic Opportunity for their review and comments. The Planning Board will review the draft elements and map series and provide a recommendation to City Council for the City Council's June 21, 2021 meeting. It is then the City Council that will take the final action to transmit the updated Comprehensive Plan to the State.
