#### **Recap of Noise Ordinance 20-05**

**Objective:** To create a fair, reasonable, constitutional, and enforceable ordinance for the City of Marco Island

Policy decisions voted on last October 2020

- Time of day
- How far away (distance from source)
- Decibels vs. non-decibels (how loud is too loud)
- Enforcement / Penalties

## Statistics regarding Noise Ordinance 20-05

#### Noise Calls

- 374 reported complaints, 70 verified for 18% violation rate
  - Average 61 reported complaints a month with 5 being verified
- Unique addresses during this period 55 houses
- Repeat addresses during this period 15 houses


#### Caller Data

- 374 calls received, 216 unique callers, 109 repeat callers, and 49 anonymous
  - 1 phone number called 17 times on 3 different addresses with 1 verified complaint (6%)
  - 2 phone numbers called 9 times each with 2 (22%) and 4 (44%) verified complaints

#### • Time of Day

- 7pm-8pm: 16 calls with 4 verified
- 8pm-9pm: 21 calls with 10 verified (Plainly Audible starts)
- 9pm-10pm: 24 calls with 10 verified


#### "Plainly Audible" Standards

Plainly Audible means any sound that can be clearly heard and understood by a reasonable person using such person's ordinary auditory senses, so long as the person's hearing is not enhanced by any device, such as a hearing aid.


Plainly Audible standard is in effect:

- Between the hours of 8pm and 7am
- 50 feet from the property line of the source of the sound <u>OR</u> within a fully enclosed structure or residence on any receiving property.

#### Inconsistencies between Plainly Audible and Sound Pressure (Decibel) Level Limits for Marco Island

Receiving Land Use Category	Time	Sound Pressure Level Limit (dBA)
Residential zone, public space, or institutional zone	7:00 a.m.—8:00 p.m. 8:00 p.m.—7:00 a.m.	66 60
Commercial zone	7:00 a.m.—9:00 p.m. 9:00 p.m.—7:00 a.m.	72 65

Multifamily dwellings and duplexes. In the case of multifamily dwellings and duplex dwelling units, it shall be unlawful to create or permit to be created any sound that exceeds a sound pressure level of 50 dBA, during the hours between 7:00 a.m. to 9:00 p.m., or 45 dBA during the hours between 9:00 p.m. and 7:00 a.m., daily, measured from a neighbor's dwelling unit within such multifamily or duplex structure. The plainly audible standard does not apply in multifamily dwellings and duplexes.

#### Recommendations

- Moving the time period for Plainly Audible from 8 pm to 11 pm
- Increasing decibel levels during day from 66 to 70 in residential
- Change the times associated with decibels in residential zones to match the commercial zone times: 7 am – 9 pm (Day) and 9 pm – 7 am (night)
- Continue with current Fine levels

## **Current Enforcement and Penalties**

Noise maker (if different from owner of residence)

Civil Citation - \$250 fine

Homeowner

Notice of Violation – warning, \$250, \$500, \$1000, \$2000, \$4000, \$5000

Notes:

 No Warnings are issued after 11pm (between 11pm-7am): automatic fine. Each subsequent call in the next 48 hours, the fine goes up based on magistrate. Fines escalate during a rolling 12-month period.
