

## **RESOLUTION 21-45**

**A RESOLUTION TO REVISE EXISTING FEES FOR THE USE OF MARCO ISLAND PARKS AND RECREATION FACILITIES. AMENDING THE FEES SCHEDULE PROVIDED FOR IN THE CITY OF MARCO ISLAND CODE OF ORDINANCES, CHAPTER 34, PARKS AND RECREATION; PROVIDING FOR INCORPORATION, CONFLICT AND SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Marco Island is the owner and operator of Parks and Recreation facilities; and

**WHEREAS**, the Parks and Recreation Department is charged with the responsibility of managing these facilities; and

**WHEREAS**, the Marco Island Racquet Center is a facility owned by the City of Marco Island and managed by the Parks and Recreation Department; and

**WHEREAS**, it is desirable for the City of Marco Island to establish fees for the use of the Marco Island Racquet Center; and

**WHEREAS**, the City Council is authorized to change, delete, or add to the listed fees by resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARCO ISLAND, FLORIDA:**

**Section 1.** In accordance with the provisions of Code, the schedule of fees, costs and other charges identified as “Exhibit A” and attached hereto shall be adopted and maintained in the City Clerk’s office and available for public inspection during normal business hours.

### **Section 2. Incorporation, Conflict, and Severability.**

1. It is the intention of the City Council, and it is hereby resolved that the provisions of this resolution shall become and be made a part of the Code of Ordinances of the City of Marco Island, Florida, and that the sections of Chapter 34 may be renumbered or re-lettered and that the word “ordinance” may be changed to “section,” “article,” or other appropriate word.
2. All sections or parts of sections of the Code of Ordinance of the City of Marco Island, all ordinances or parts of ordinances, all resolutions, or parts of resolutions in conflict herewith, be and the same, are hereby Repealed to the extent of the conflict.
3. If any word, phrase, clause, subsection, or section of this resolution is for any

reason held unconstitutional or invalid by a court of competent jurisdiction, the invalidity thereof shall not affect the validity of any remaining portions of the resolution.

**Section 3. Effective Date.**

This Resolution shall take effect on October 1, 2021.
