Recognition

Firefighter Paramedic Anthony Gordon was appointed to the position of Field Training Paramedic. Anthony is a 15-year veteran with significant paramedic experience and has a passion for teaching and mentoring the departments paramedics and EMT's.

Public Education/Community Outreach

- During the month of September, staff certified 21 CPR & 1st Aid students.
- Crews conducted a six-hour training for "Leadership Marco" on September 22nd.





Significant Incidents

- On Sept 4th, crews responded to a vehicle vs home in the Rose Ct area, no injuries and minor damage to the home.
