(a) ID 19-455 SITE DEVELOPMENT PLAN - Tigertail Beach Tractor Canopy at 480 Hernando Dr., Marco Island, FL 34145 (SDP-19-000931)

Planner Sherry Hoyo read into the record the details of application for the the site development plan request. City Attorney Paul Googleman swore in all witnesses and Planning Board members provided their ex parte communications.

Planner Mary Holden presented the project. Planner Holden and Director Smith responded to board members questions, and advised that staff is recommending approval.

(b) ID 19-456 SITE DEVELOPMENT PLAN - Windward Drive Commercial Warehouse at 921 Windward Dr., Marco Island, FL 34145 (SDP-19-000919)

Planner Sherry Hoyo read the details of SDP-19-000919 into the record. City Attorney Paul Goggleman swore in all witness and ex parte communications were provided by Planning Board members.

Planner Jason Smalley presented the project and mentioned the requirement that the pervious paver drain system will need to be maintained. He and Director Smith responded to board members questions. Stormwater Engineer Jason Tommassetti also reponded to questions regarding stormwater management and the pervious paver requirement.

The appliciant, Jim Moyer, also responded to board members question and concerns.

Attorney Lenore Brakefield, representing the appliciant, spoke in oppositon to the staff conditions and requested that conditions be omitted.
