Chair Woodworth commented on the recent algae blooms seen in the canal behind his residence and other canals throughout Marco Island and displayed photographs. He reported algae blooms to Collier County. Principal Environmental Specialist, Rhonda Watkins who advised him the algae is called "benthic algae mats" and can be removed by surface skimming. Public Works Director Tim Pinter advised the test results indicate it is a non toxic algae. Chair Woodworth provided the following contact points to report algae blooms:

2019 Resolution
