He feels that there should be more control and restriction to limit waste going into the canals.

b. Fish Kill Cleanup - Chair Woodworth

Member Sokol stated that when it comes to picking up dead fish you do not need a permit however it does matter where the fish are being dumped. Looking into it Member Sokol was able to find that with a permit his company can gather the fish and dump it 3 miles or father off shore.

Chair Woodworth presented some question, answers, and history of the MS4 Ordinance to the committee and the floor. The committee's goal with this information is to either amend or create a new MS4 Ordinance.
