## BACKGROUND:

Business: City Council Item

As part of FY23 operating budget, City Council approved Intelligent Traffic System (ITS) study as one of the new initiatives and priorities. ITS is an intersection and traffic signal study for a better traffic flow on Marco Island roads.
